

TASMANIAN RACING APPEAL BOARD

PROCEDURES WITH REGARD TO APPEALS AGAINST DECISIONS OF STEWARDS

A person may appeal to the Tasmanian Racing Appeal Board if the person is aggrieved by the decision of the stewards to:

- (a) impose a fine on the person, or
- (b) impose a suspension or disqualification on the person or on a horse or greyhound owned, leased or trained by the person.

The notice of appeal must be lodged with the Secretary as follows:

- (a) For a minor appeal (a fine not exceeding \$500 or a suspension for a period not exceeding 30 days*) documents **MUST** be lodged within **SEVEN (7)** days after the imposition of the penalty together with a deposit of **\$200.00**.
- (b) For a major appeal documents **MUST** be lodged within **fourteen (14)** days after the imposition of the penalty together with a deposit of **\$500.00**.

** If the penalty is expressed in race dates, please ensure that you ascertain how many days that relates to.*
