Application to extend the term of a Dam Works Permit (Division 3 Permit)

Use this application form to apply to extend the term of a Permit to undertake dam works (Division 3 Permit) under Section 164E of the *Water Management Act 1999*. This application must be made at least one month before the expiry of a current Division 3 permit.

The term of a Division 3 permit may only be extended once for a maximum of two years

Steps to Completing this Application to Extend the Term of a Division 3 Dam Works Permit

1. Complete all the information in this application form

Section 1 deals with details of the applicant; who they are, and how to contact them.

Section 2 deals with details of permit and the reason for the extension to the term of the permit.

Section 3 is a declaration to be signed stating that all the information provided is true and accurate.

2. Sign the declaration set out in section 3.

3. Submit the completed and signed application form.

There are two options for submitting the completed application form;

- Post the completed application form, with the prescribed fee, in the form of a cheque or money order (made payable to DPIWPE), to:

or
- Lodge the completed application form, with the prescribed fee, at any Service Tasmania outlet.
