Landowner Consent to Proposed Dam Works
and/or any Inundation of Land under a Dam Works Permit

For the Applicant for a Dam Works Permit

Use this form to demonstrate consent from any landowner when:

- You do not own the land where the proposed dam works will be undertaken; or
- The proposed dam works will result in the inundation of land owned by another person.

If your proposed works affect more than one landowner then complete a separate form for each landowner.

For the Land Owner

For a person to obtain a permit to undertake dam works under Division 4 of the *Water Management Act 1999* on land that they do not own (which includes the inundation of land as a consequence of the construction of a dam) they must provide the Minister evidence in writing that the owner of that affected land is aware of and consents to the proposed dam works or any inundation. This form is to be used to provide that written consent.

As the owner of land with a dam on it, or inundated with water in a dam for the purposes of the *Water Management Act 1999* you will be an owner of that dam. Details of these responsibilities are set out on the Department's Dam Safety web page: <http://dpiuwe.tas.gov.au/water/dams/dam-safety>

Steps to Completing this Form

- 1. If the form is being completed by a company or a partnership** then all members of any Partnership / Joint Venture must also complete a Membership Details Form and attach it to this Notice. A consent form pertaining to Partnership / Joint Venture will not be accepted by the Department without a fully completed Membership Details Form. - 2. Complete all the information in this application form**
Section 1 deals with details of the land owner; who they are, and how to contact them
Section 2 deals with details of the property where the dam is to be built
Section 3 deals with specifications of the dam; its height, capacity, etc.
Section 4 is a declaration to be signed stating that all the information provided is true and accurate.
- 3. Sign the declaration** set out in section 4
- 4. Submit the completed and signed consent form**

Under the *Water Management Act 1999*, a person must not furnish information to the Minister, a water entity or an authorised officer that is false or misleading in a material particular. Your personal information will be used for the primary purpose for which it is collected, and may be disclosed to contractors and agents of the Water & Marine Resources Division, law enforcement agencies, courts and other organisations authorised to collect it. Your basic personal information may be disclosed to other public sector bodies where necessary, for the efficient storage and use of the information. Personal information will be managed in accordance with the *Personal Information Protection Act 2004* and may be accessed by the individual to whom it relates on request to DPIUWE.
