

Application Change the Offtake Location of an Existing Water Allocation

Use this Application form if you wish to change the location where you take your water under a water allocation under the *Water Management Act 1999*.

Allocations may only be moved up or down connected water resources. When moving the offtake point of an allocation upstream there is generally a smaller catchment area and yields are likely to be reduced. This may result in the allocation having to be reduced in order not to impact upon existing users or the environment. When moving the offtake point of an allocation downstream the catchment area generally increases and water availability usually will increase although this may not always be the case. In both instances an assessment of the water availability at the new offtake location will be undertaken by the Department once the application has been submitted.

When assessing the application the Department will consider water availability at the offtake, the sub-catchment and the catchment and determine whether the water may be allocated without having an adverse impact upon existing users and/or the environment at any of these levels. When determining the coordinates for the new offtake the eastings and northings must be provided using the GDA 94 and these can be readily determined using the LISTMap web site at <https://maps.thelist.tas.gov.au/listmap>

When considering your options in relation to moving an offtake point it is recommended you contact a Regional Water Management Officer at your local DPIPWE office and seek guidance from them as to your options.

Steps to Completing this Form

Licence Holder Details

Here enter name of the water licence holder. This is printed on the upper left hand side of the Water Licence. The Department also seeks to ensure that it has the most up to date contact information for you and so asks that you provide a phone number and email address that can be used to contact you should it be necessary.

Licence and Offtake Details

You must provide the water licence number which is on the top right hand side of your water licence. This number can also be looked up on the WIST web site: <http://wrt.tas.gov.au/wist> and then using the water entitlements section and searching by client name.

You then have to identify the allocation that is to be moved. You must provide the allocation number and the period amount of that allocation along with the easting and northing and the name of the water resource where the allocation is currently taken. As noted above the eastings and northings must be provided using the GDA 94.

You must then provide the new eastings and northings (again using the GDA 94) and the name of the water resource where you seek to take the allocation from in the future.

Submit the completed and signed application form

There are two options for submitting the completed application form;

- Post the completed application form, with the prescribed fee, in the form of a cheque or money order (made payable to DPIPWE), to
