**APPLICATION TO OBTAIN A COPY OF, OR AN EXTRACT
FROM, THE REGISTER OF DAMS & DAM PERMITS**

Use this form to request the Department search the Register of Dams and Dam Works Permits for records of either Dam Works Permits issued to a particular person, company or partnership or for dams on a particular property.

This information is available to the public through the <https://maps.thelist.tas.gov.au/listmap/app/list/map> web site then selecting the three layers for "Dam Permit Locations" under Primary Industries/Farming.

- Blue dots represent existing dams where the Department has confirmation that a dam has been built;
- Yellow dots identify where a dam works permit has been granted but the Department has not received confirmation from the Permit holder whether the dam has been built or not;
- Grey dots identify where a permit may have been applied for but was either subsequently withdrawn or refused, or where a dam has failed or where a dam has been enlarged and superseded by a new dam

If you go ahead with completing and submitting this form you will receive a letter from the Department providing details of any records in the Register of dams and dam works permits with information on the recorded capacity of the dam, the year the permit was approved or the dam was built (if available) and the assessed consequence category of the dam.

Steps to Completing this Form

1. Complete all the information in this application form

Section 1 deals with details of the person making the application; who they are, and how to contact them
Section 2 deals with the permit numbers, if known, or the name of the permit holder
Section 3 deals with details of the property where you are interested in any dams .

2. Submit the completed form

There are two options for submitting the completed form;

- Post the completed form, with the prescribed fee, in the form of a cheque or money order (made payable to DPIPWE), to:
DPIPWE, Water Management & Assessment Branch, PO Box 44, Hobart TAS 7001,
or
- Lodge the completed form, with the prescribed fee, at any Service Tasmania outlet.

Personal information will be collected from you for the purpose of managing Tasmania's water resource and will be used by DPIPWE for purposes permitted by the Water Management Act 1999 and regulations made under this Act. Under the Water Management Act 1999, a person must not furnish information to the Minister, a water entity or an authorised officer that is false or misleading in a material particular. Your personal information will be used for the primary purpose for which it is collected, and may be disclosed to contractors and agents of DPIPWE, law enforcement agencies, courts and other organisations authorised to collect it. Your basic personal information may be disclosed to other public sector bodies where necessary, for the efficient storage and use of the information. Personal information will be managed in accordance with the Personal Information Protection Act 2004 and may be accessed by the individual to whom it relates on request to DPIPWE.
