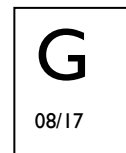

I declare that the information provided in this application, is to the best of my knowledge, true and correct. I am also aware that it is a serious offence under the Tasmanian Greyhound Rules of Racing to provide false and misleading information. In the event of such registration being granted, I acknowledge:

- (a) That the said registration is granted on the understanding that it is reviewable, at least on an annual basis and the Director of Racing may impose any condition, revoke the registration at any time during the period of issue or refuse to renew the registration in accordance with the Rules of Racing.
- (b) That I shall be bound at all times by the Policies and Rules of Racing in the State of Tasmania.
- (c) That I will comply with any directions, which may be given by the Director, Stewards or officials.
- (d) I may be required to provide such additional information as shall be reasonably required by the Director in respect of this application.
- (e) At the date of this application I am 18 years of age or older.
- (f) Any Certificate of Registration that may be issued to me is, and will remain the property of the Office of Racing Integrity, Tasmania and will be produced or returned on demand made by an Authorised Officer of the organisation or by a Steward.
- (g) I am aware that ORI is collecting this information for the purpose of administering and promoting greyhound racing. I understand that ORI only discloses this information to organisations which help to administer and promote greyhound racing and in order to comply with applicable laws and regulations.
- (h) I agree that I am bound by Tasracing's Conditions of Entry (available on Tasracing's website at www.tasracingcorporate.com.au/conditions-of-entry) as set down from time to time by Tasracing at both training and racing venues.
