GREYHOUND RETIREMENT NOTIFICATION

(To be used when retiring a Greyhound to GAP, 3rd Party, Other Adoption program or Export)

The greyhound ID card or Naming Application Form **MUST** be returned with this notification

GAR106(3) At any time after the notification of the result of service pursuant to Rule 136, the last registered owner of the greyhound at the relevant time, shall notify the Controlling Body by lodging the prescribed form:

(a) Within ten working days, if that greyhound has transferred ownership, been retired as a pet or a breeding greyhound, been transferred to an adoption program, exported or surrendered to another agency
