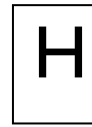

I/We hereby authorise my/our trainer, being the person who has lodged with the Office of Racing Integrity, Tasmania a current stable return in respect of the above horse, to enter the horse for this type of race and to vary the claiming price of the horse to an amount not less than the minimum claiming price.

I/We declare that the horse referred to herein is solely my/our horse and there is/are no other person/s having any share or interest in the horse and I/we shall relinquish ownership of the horse or any other interest I/we may have in the horse by my/our signature/s on this document in the event of a successful claim. In such event, this document becomes and forms part of the transfer documents.

In the event of the horse being subject to a lease, the lessor agrees to pay the lessee, **within 28 days** of the horse being claimed, the sum of money equivalent to \_\_\_\_\_% (**Percent**) of the gross claiming price received by the lessor for the horse and in the event of the said horse being claimed both lessor/s and lessee/s agree that this document determines the lease and is deemed notification of the termination of the lease as required.
