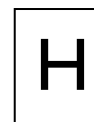

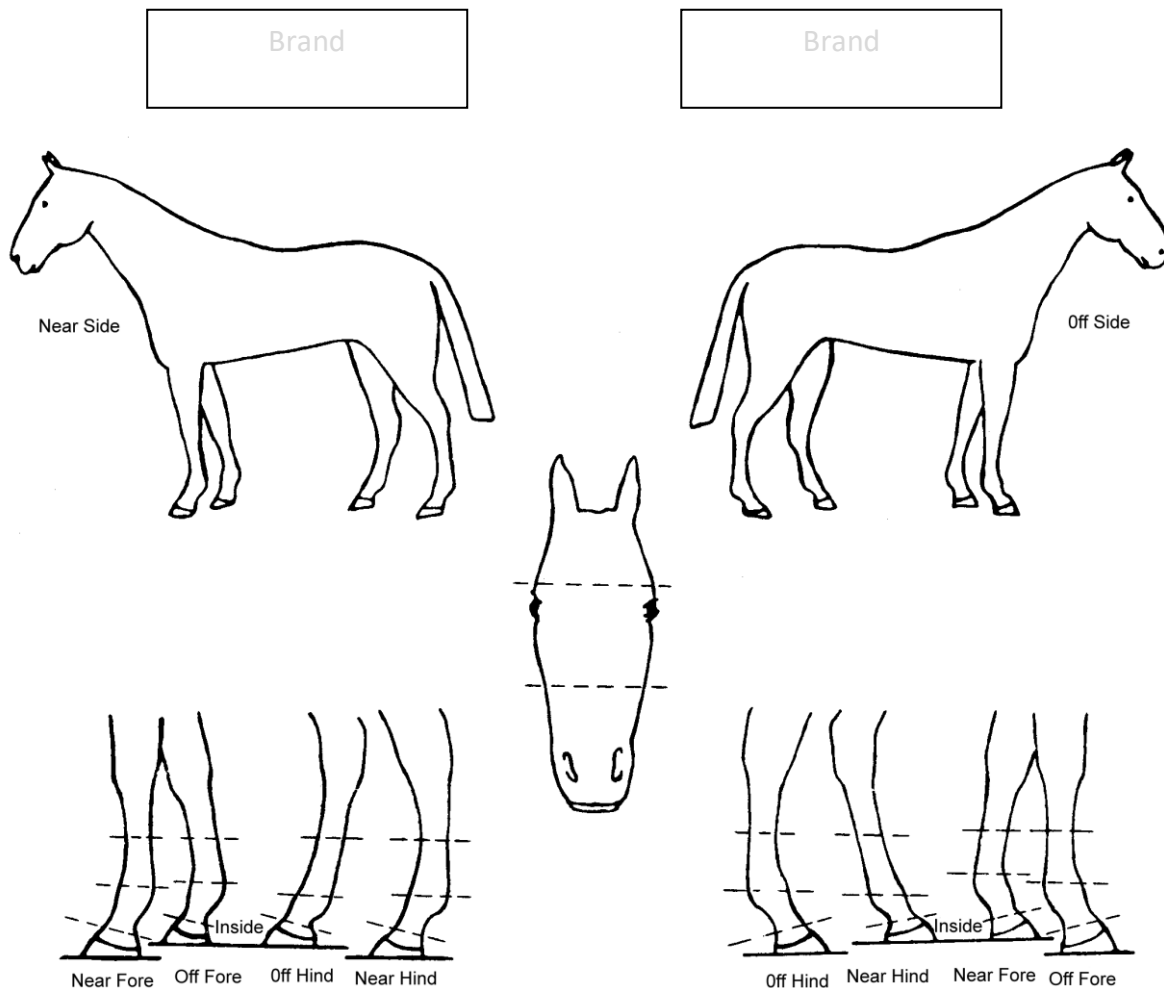

5. The description of each marking must be noted under the diagram. If no markings, 'nil' must be stated.
6. The microchip number (if applicable) must be recorded in the box below.
