Your address details may also be disclosed to the Tasmanian Seafood Industry Council (TSIC) to enable notification of industry updates, annual general meetings and Board elections, and to enable the *Fishing Today* publication to be forwarded to you.

Personal information will be managed in accordance with the *Personal Information Protection Act 2004* and may be accessed by the individual to whom it relates on request to DPIPWE. You may be charged a fee for this service.
