The start of this event was delayed 1 minute due to Shepparton Greyhounds Race 2 running behind schedule.

On the first turn Eliza Dee, Kiss Me Victor and Tom Tom Drum bumped, checking Kiss Me Victor. At the same time Hasta De Kahn checked off the heels of Cannon. On the second turn Tom Tom Drum checked off the heels of Pepper Rock and as a result Tom Tom Drum bumped with Eliza Dee. Kiss Me Victor raced wide in the back straight. Approaching the third turn Tom Tom Drum checked off the heels of Mega Daario, checking Tom Tom Drum and Cannon. In the home straight Eliza Dee checked off the heels of Pepper Rock. Soon after Pepper Rock, Mega Daario and Eliza Dee bumped.

RACE 2 – KINGSLEY JARMAN FENCING GRADE 5 (1) 278M

Approaching the first turn Bridwood Shortly checked off the heels of Run Out Babe. On the first turn Parma Chief, Bridwood Shorty, Dilston Rebel, Spritely and Nicky Dal's Girl bumped, checking Dilston Rebel, Dilston Shorty and Spritely. Approaching the home turn Lyncar Jerry and Spritely bumped. On the home turn Bridwood Shortly, Bearville Wigi and Dilston Rebel bumped, checking Dilston Rebel and Bridwood

Shorty. At the same time Lyncar Jerry and Spritely bumped, checking Spritely. Approaching the winning post Run Out Babe and Nicky Dal's Girl bumped. Dilston Rebel underwent a post-race veterinary examination and was found to have an injured toe nail on its left hind leg. Dilston Rebel has been stood down for 5 days. Bridwood Shorty underwent a post-race veterinary examination and no apparent injury could be detected.

RACE 3 – BRIAN HUDSON APPRECIATION STAKES GRADE 6 (2) 515M

Jay Em Dee and Yakan De Kahn bumped, checking Jay Em Dee. Approaching the first turn Our Diamond and Yakan De Kahn bumped. On the first turn Silver Drone, Yakan De Kahn, Our Diamond and Tee Cee Benny bumped, checking Yakan De Kahn, Our Diamond, Tee Cee Benny and Platinum Judy and as a result Yakan De Kahn and Our Diamond fell. Silver Drone tired over the concluding stages. Yakan De Kahn underwent a post-race veterinary examination and no apparent injury could be detected. Our Diamond underwent a post-race veterinary examination and was found to have superficial grazes to its left hind and front legs. Our Diamond has been stood down for 5 days. A post-race swab sample was taken from Chloe Mac, winner of the event.

Soon after the start Ty's Houdini and Keep Ya Stripes bumped. Approaching the first turn Keep Ya Stripes, Dilston Delight and Billy Jo bumped, checking Keep Ya Stripes and Dilston Delight. On the first turn Billy Jo and Dilston Delight bumped, checking Dilston Delight, Keep Ya Stripes and Dilston Loch. Lancie Boy raced wide around the first turn.

RACE 5 – A TOTAL CAR RENTALS GRADE 5 (1) 515M

Buckle Up Labi was a late scratching at 11.55am by reason of injury pursuant to GAR 37(2). Buckle Up Labi has been stood down from racing for a period of 10 days and trainer Mr G Johnson was advised that he must produce a vet certificate to the Office of Racing Integrity confirming the injury within 48 hours pursuant to LR 25.6.

Legana Lad was a late scratching at 6.40pm due to a weight variation. Legana Lad has been stood down from racing for a period of 10 days and trainer Mr M Eales was subsequently fined the sum of \$50.00 pursuant to GAR 39(3).

Zippering Elvis was slow out. Soon after the start Suzy La Rue and Shack View bumped. Approaching the first turn Dziah and Posh Renee bumped. On the first turn Blaster Master, Suzy La Rue and Shack View bumped, checking Blaster Master and Suzy La Rue. On the second turn Posh Renee, Zippering Elvis and Shack View bumped, checking Zippering Elvis and Shack View. Entering the back straight Blaster Master and Suzy La Rue bumped. On the third turn Blaster Master checked off the heels of Suzy La Rue. In the home straight Zippering Elvis checked off the heels of Dziah.

RACE 6 – SIMONS CARPET ONE GRADE 5 (2) 515M

Soon after the start Unimaginable crossed to the rails, checking Keep Ya Looks and Cooper's Shadow. Approaching the first turn Jinx and Buckle Up Jones bumped, checking Jinx. On the second turn Buckle Up Jones checked off the heels of Locknane Bill and as a result Buckle Up Jones and Waddlesworth bumped. Soon after Jinx and Waddlesworth bumped. In the back straight Buckle Up Jones and Locknane Bill bumped, checking Locknane Bill, Jinx and Cooper's Shadow. In the back straight Jinx checked off the heels of Waddlesworth. On the home turn Jinx and Keep Ya Looks bumped. At the same time Waddlesworth and Unimaginable bumped. Entering the home straight Waddlesworth and Unimaginable bumped, checking both greyhounds. Soon after Unimaginable marred the running of Waddlesworth. Unimaginable underwent a post-race veterinary examination and no apparent injury could be detected. Stewards spoke to trainer Mr B Deverell in relation to Unimaginable's racing manners around the home turn and entering the home straight. Acting on their own observations, viewing the official replays and taking evidence off Mr Deverell, Stewards were of the opinion that Unimaginable had turned its head outwards and made head or muzzle contact with waddlesworth and by doing so had marred the running of that greyhound pursuant to GAR 69(1). Acting under the provisions of GAR 69(2)(a) Unimaginable has been stood down from racing for a period of 28 days at Launceston only and until the completion of a satisfactory trial. Keep Ya Looks underwent a post-race veterinary examination and was found to have a strained right hind tensor facia muscle. Keep Ya Looks has been stood down from racing for a period of 10 days. A post-race swab sample was taken from Buckle Up Jones, winner of the event.

Approaching the third turn Work It checked off the heels of Dean Machine. A post-race swab sample was taken from Take Time Tracy, winner of the event.
