RACE 1 – A TOTAL CAR RENTALS GRADE 6 515M

Gunna's Lady was very slow out. Soon after the start Adam's Bandit and Le Baz bumped. Shortly after Inanna Star and Joster bumped. Approaching the first turn Tom Tom Drum and Tee Cee Benny bumped. On the third turn Tom Tom Drum checked off the heels of Adam's bandit, checking Le Baz. On the home turn Le Baz, Tom Tom Drum and Honest Rosie bumped resulting in Le Baz galloping on the heels of Tom Tom Drum, checking both greyhounds. Gunna's Lady underwent a post-race veterinary examination and no apparent abnormalities could be detected. Tom Tom Drum underwent a post-race veterinary examination which revealed the greyhound to have superficial scrapes and minor bruising to both hind legs. Tom Tom Drum has been stood down from racing for a period of 5 days.

RACE 2 – KINGSLEY JARMAN FENCING GRADE 6 (1) 278M and Platinum

Soon after the start Buckle Up Alex and Adam's Lilly bumped, checking Buckle Up Alex. In the back straight Whip Carter and Platinum Kelly bumped. On the first turn Fames The Aim crossed to the rail, checking Kath Emery and Suspect Nargles and as a result Whip Carter was checked. At the same time Buckle Up Alex and Platinum Kelly bumped. Shortly after Whip Carter and Dylan Keeping bumped. Approaching the home turn Platinum Kelly, Whip Carter and Dylan Keeping bumped. On the home turn Platinum Kelly and Dylan Keeping bumped. At the same time Buckle Up Alex checked off the heels of Kath Emery. Shortly after Fames The Aim and Adam's Lilly bumped. Entering the home straight Platinum Kelly and Dylan Keeping bumped, checking Dylan Keeping.

Platinum Di was a late scratching at 6.40pm after being examined by the veterinary surgeon the greyhound was found to be in season. Platinum Di has been stood down from racing for a period of 28 days, pursuant to GAR 24(4).

Adam's Snow was slow out. Soon after the start Yakan De Kahn and Wicked Turtle bumped, checking Wicked Turtle. On the first turn Greysynd Gem, Yakan De Kahn, St. Marsielle, Suva and Adam's Snow bumped, checking Yakan De Kahn, St. Marcielle, Suva and Adam's Snow. Approaching the home turn Wicked Turtle checked off the heels of Adam's Snow. A post-race swab sample was taken from Greysynd Gem, winner of the event.

RACE 4 – CURTAINS & BLINDS JG 600M

Our Mate Jake, Tamar Jet, Blatter and Miss Myra were slow out. On the first turn Our Mate Jake and Tamar Jet bumped, checking Tamar Jet. Shortly after lady Rappa, Blatter and Miss Myra bumped, checking Blatter which bumped with Our Mate Jake. Entering the front straight Happy Jeff checked off the heels of Tah Stella. Entering the front straight Happy Jeff checked off the heels of Tah Stella. In the front straight Our Mate Jake crossed wide, checking Blatter and Tamar Jet. On the third turn Blatter checked off the heels of Happy Jeff. Miss Myra tired over the concluding stages. Our Mate Jake underwent a post-race veterinary examination and no apparent injury could be detected. Trainer Mr G Fahey stated that it was his intention to race the greyhound at Devonport or Hobart in the future after it had failed to perform at its five Launceston starts.

RACE 5 – RAPIDVITE NO PENALTY FINAL 5/4NP 278M

Triple Century and Boozy Rose were slow out. On the first turn Spritely, Posh Faith, Dilston Rebel and Luke Roman bumped, checking Posh Faith. Shortly after Triple Century and Boozy Rose bumped, checking Boozy Rose. Approaching the home turn Dilston Rebel checked off the heels of Golden Nugget and as a result contacted the rail and the shifted out checking Posh Faith and Spritely. Dilston Rebel underwent a post-race veterinary examination and no apparent injury could be detected. Posh Faith underwent a post-race veterinary examination and no apparent injury could be detected.

RACE 6 – SIMONS CARPET ONE GRADE 5 (1) 515M

Soon after the start Jinx and Kalimna bumped. Approaching the first turn Ambivalence and Fancy Moss bumped. At the same time Swift Mover crossed to the rail, checking Bridwood Goldy. Shortly after Kalimna checked off the heels of Jinx. On the first turn Lyncar Teagan, Bridwood Goldy and Cheeky Ella bumped, checking Bridwood Goldy and Cheeky Ella. Shortly after Ambivalence and Fancy Moss bumped, resulting in Fancy Moss checking off the heels of Cheeky Ella. Entering the back straight Ambivalence and Cheeky Ella bumped. On the home turn Bridwood Goldy and Fancy Moss bumped. Swift Mover faulted and lost ground rounding the home turn. In the home straight Kalimna checked off the heels of Swift Mover, checking Jinx. Approaching the finish Jinx and Ambivalence bumped, checking Ambivalence. Bridwood Goldy and Fancy Moss raced wide in the home straight. Swift Mover underwent a post-race veterinary examination which revealed the greyhound to have muscle soreness to the left should. Swift Mover has been stood down from racing for a period of 10 days. Stewards spoke to trainer Mr N Howard in relation to the race manner of Swift Mover rounding the home turn. After taking evidence from Mr Howard, viewing the official replays and acting on their own observations Stewards took into account the nature of the injury sustained by Swift Mover and as such took no further action against the greyhound.

RACE 7 – LUXBET RACING CENTRE MIXED 3/4 515M

Take The Crown and Turbo Riley were slow out. Soon after the start Storm Chief and Furious Floss bumped. On the second turn Jadeite and Storm Chief bumped, checking both greyhounds and as a result Take The Crown was checked. On the third turn Storm Chief crossed to the rail, checking Jadeite and Take The Crown. Storm Chief underwent a post-race veterinary examination and no apparent injury could be detected.

RACE 8 – LAUNCESTON MITSUBISHI GRADE 4 515M

Soon after the start Posh Renee, Tah Sophie, Half Century and Satin Style bumped, checking Half Century and Satin Style. Approaching the first turn Satin Style, Winklee Toby, Strait Ate and Posh Renee bumped, checking Posh Renee. On the second turn Posh Renee and Winklee Toby bumped, checking both greyhounds. On the home turn Capra Ross and Nebraska Beach bumped, checking Nebraska Beach. Approaching the finish Half Century and Satin Style bumped. Nebraska Beach underwent a post-race veterinary examination and no apparent injury could be detected. Posh Renee underwent a post-race veterinary examination and no apparent injury could be detected. Winklee Toby underwent a post-race veterinary examination which revealed the greyhound to have a laceration behind the left dew claw. Winklee Toby has been stood down from racing for a period of 10 days. A post-race swabs sample was taken from Capra Ross, winner of the event.

RACE 9 – CARLTON DRAUGHT GRADE 5 278M

Lynkar Jerry was slow out. Soon after the start Stylish image, racy Gracie and Low Flying Plane bumped, checking all three greyhounds. Approaching the first turn Racy Gracie and Stylish Image bumped, resulting in Racy Gracie checking off the heels of Shogun Steel. On the first turn Shogun Steel and Bomber Heppell bumped, checking Bomber Heppell, Low Flying Plane, Racy Gracie and Stylish Image.

GENERAL

Seabrook Keely completed a Stewards satisfactory trial as it was stood down from the Launceston Greyhound Racing Club on the 10 October 2016 for an unsatisfactory performance pursuant to GAR 71. Weighing 27.5kg and beginning from box 3 Seabrook Keely completed the 515m trial distance in a time of 30.79. Seabrook Keely has been cleared to race at all tracks.
