RACE 2 – CALVALRY 1940 4/5NP (1) 461M

Boomers Revenge underwent a pre-race veterinary examination after it was found to have chewed its bedding at kennelling and was passed fit to run.

Soon after the start Nicky Dal's Girl and Missile Ben bumped, checking Missile Ben. Soon after Boomers Revenge, Family Challenge and Nicky Dal's Girl bumped, checking Boomers Revenge. Soon after Coolan Mist faulted and pulled up, failing to finish the event. Approaching the first turn Winklee Dokey checked off the heels of Family Challenge. Soon after Boomers Revenge faulted and subsequently pulled up on the home turn for a short time and then finished the event. Boomers Revenge underwent a post-race veterinary examination which revealed muscle soreness to its right hind leg. Boomers Revenge has been stood down from racing for a period 10 days. Stewards spoke to trainer Mrs G Townsend in relation to the racing manners of Boomers Revenge on the first turn. Acting on their own

observations and taking evidence off Mrs G Townsend, Stewards were of the opinion that Boomers Revenge had eased and by doing so had failed to pursue the lure with due commitment throughout the event by reason of injury. Pursuant to GAR 69B(1)(a) Boomers Revenge has been stood down until the completion of a satisfactory trial. Coolan Mist underwent a post-race veterinary examination which revealed a ruptured right hind leg muscle. Coolan Mist has been stood down from racing for a period of 28 days.

Winnie Kicks was a late scratching at 6.49pm after being found by the veterinary surgeon to be in season, pursuant to GAR 24(4) Winnie Kicks has been stood down from racing for a period of 28 days.

Soon after the start Coolan Prince, Family Chief and Winklee Sheila bumped, checking Family Chief and Winklee Sheila. Approaching the first turn Winklee Colin and Simpsons Bay bumped. On the first turn Winklee Colin, Wasbah and Coolan Prince bumped, severely checking Coolan Prince and Wasbah and checking Family Chief. Coolan Prince underwent a post-race veterinary examination which revealed a laceration to its left thigh muscle. Coolan Prince has been stood down from racing for a period of 10 days. Wasbah underwent a post-race veterinary examination and no apparent injury could be detected. A post-race swab sample was taken from Simpsons Bay, the winner of the event.

GENERAL
