

## STIPENDIARY STEWARDS' REPORT

### RACE 1 – CATARAQUI ANGUS MAIDEN – SET WEIGHTS – 1000 METRES

The start of this race was delayed when **Missy** had to be re-saddled behind the barriers.

**Missy** – Jumped awkwardly.

**Goldorado** – Restrained at approximately 800 metre mark when receiving pressure from the outside. The gelding had to be restrained shortly after to avoid the heels of Ex Words.

**Ex Words** shifted out under pressure over the concluding stages of the event.

### RACE 3 – TOM WILSHIRE MEMORIAL CLASS A HCP 1000 METRES

**Comsuadi** – jumped awkwardly at the start. The mare hung out at approximately the 700m and had to be steadied to avoid the heels of Mr Monarch. Rounding the home turn shifted ground outwards. Rider Christopher Brown was reminded of his obligations when shifting ground outwards.

**Mr Monarch** – Tara Jane-Mitchell had to be steadied to avoid the heels of Comsuadi when the mare shifted out.

### RACE 4 – CONLEY & WILLIAMS MEMORIAL MAIDEN 1200 METRES

**Dashing Devon** – over raced in the middle stages of the event.

**Undo the Shackles** – underwent a post-race veterinary examination when it revealed the gelding was distressed on returning to scale. The gelding has been stood down and is required to undergo an ECG and a veterinary certificate of soundness provided before starting again.

**Take On Me** - layed in the home straight.

### RACE 6 – HODGE TRANSPORT MAIDEN 1400 METRES

**Dakasha's Pride** – Christopher Brown the rider of the mare was found guilty of a charge of careless riding. The particulars being near the 1250 metres when attempting to cross to the rails when insufficiently clear of **Bring On Friday** resulting in that mare clipping heels, blundering and the rider becoming unbalanced. Jockey C Brown's licence to ride in races was suspended for 1 Tasmanian race meeting commencing midnight 7/12/2016 and expiring midnight 8/12/2016. Jockey Christopher Brown pleaded guilty to the charge.

**Bring On Friday** over raced in the early and middle stages of the event.

**Love Quest** – resented the whip over the concluding stages.

### RACE 7 – JBS AUSTRALIA CLASS B HANDICAP – 1400 METRES

**Pashmak** - Stewards granted permission for rider C Brown to ride 1kg over his allotted weight.

**Dubai Hero** – rider took hold soon after the start to avoid heels of Next Issue.

**Kilmany** – jumped the crossing at the 1000m, the gelding underwent a post-race veterinary examination and no abnormalities could be detected.

**Mr America** – jumped awkwardly at the start.

**Next Issue** – rider reported the gelding over raced throughout the event.
