RACE 1 – LAUNCESTON MITSUBISHI GRADE 6(1) 278M

Hasta De Kahn was slow out. Soon after the start Suva crossed to the rail checking Out Of Traction, and bumped with Fink Racer. Approaching the first turn Suva crossed to the rail checking Fink Racer and Fab Gaze. On the first turn Smooth Jinx checked off the heels of Chilly Devil, checking Suva. Shortly after, Hasta De Kahn checked off the heels of Fink Racer. On the home turn Smooth Jinx and Suva bumped. Out Of Traction underwent a post-race veterinary trial which revealed the greyhound to have grazing to the right hind webbing. Out Of Traction has been stood down from racing for a period of 5 days.

RACE 2 – KINGSLEY JARMAN FENCING GRADE 6(2) 278M

Frazzle Dazzle was slow out. Soon after the start Whip Carter crossed to the rail, checking Sooky Jooky, Witchanza Girl, Frazzle Dazzle, Platnium Di and St. Comet. Approaching the first turn Whip Carter, Platnium Di and Call Me Charlie bumped. At the same time Witchanza Girl and St. Comet bumped. Shortly after, Sooky Jooky, Frazzle Dazzle, Whip Carter, Platnium Di and Call Me Charlie bumped, checking Frazzle Dazzle, Whip Carter and Platnium Di. On the home turn St. Comet galloped on the heels of Platnium Di, checking both greyhounds. St. Comet underwent a post-race veterinary examination which revealed the greyhound to be developing a track leg on the left hind leg, however no stand down period was applied.

RACE 3 – WINNING EDGE KIBBLE GRADE 6 515M

Metanoia Franko was slow out. Soon after the start Pepper Rock crossed wide, checking Fight To Excel and Unleash. In the front straight Maharani checked off the heels of Purdie Shuffle. On the first turn Pepper Rock galloped on the heels of Maharani, checking Maharani. At the same time Fight To Excel and Unleash bumped. On the third turn, Metanoia Franko galloped on the heels of Yakan De Kahn, checking both greyhounds. On the home turn, Maharani and Fight To Excel bumped. In the home straight Pepper Rock and Fight To Excel bumped. Maharani underwent a post-race veterinary examination no apparent injury could be detected. Yakan De Kahn underwent a post-race veterinary examination and no apparent injury could be detected.

RACE 4 – THE GREYHOUND RECORDER MAIDEN 515M

Bali Or Bust and Legana Lad were slow out. Soon after the start Nanna June and Tamar Jet bumped. At the same time, Aware and Tah Ruby bumped. In the front straight Nanna June and Tamar Jet bumped, resulting in Bali Or Bust checking off the heels of Tamar Jet.. Approaching the first turn Legana Lad galloped on the heels of Bali Or Bust. Shortly after, Legana Lad crossed wide, checking Bali Or Bust. Approaching the second turn Aware and Eliza Dee bumped. In the back straight, Eliza Dee checked off the heels of Nanna June. In the home straight Eliza Dee and Nanna June bumped. Shortly after, Tamar Jet checked off the heels of Nanna June. Bali Or Bust underwent a post-race veterinary examination and no apparent injury could be detected. Stewards spoke to trainer representative Mrs J Stamford in relation to the race manner of Bali Or Bust approaching the first turn. Acting on their own observations, viewing the official replays and taking evidence from Mrs Stanford, Stewards were satisfied that Bali Or Bust had received interference from Legana Lad and, as such, took no further action against the greyhound. Legana Lad underwent a post-race veterinary examination and no apparent injury could be detected. Stewards spoke to trainer Mr M Eales in relation to the performance of Legana Lad. Acting on their own observations, viewing the official replays and taking evidence from Mr Eales, Stewards placed a warning on Legana Lad and advised Mr Eales that if the greyhound continues to race in such a manner further action may be taken.

RACE 5 – GO RACING TASMANIA GRADE 5(1) 515M

Tah Jen was a late scratching at 6.51pm on vets advice after the greyhound was examined at kennelling and found to be unclean with fleas. Pursuant to GAR 37(4), Trainer Mr A Bullock was advised that he must submit a veterinary certificate to the Office of Racing Integrity certifying that the condition no longer exists. Bobby Bound was slow out. Soon after the start Fancy Moss checked off the heels of Lashing Freda. In the front straight Lashing Storm and Adam's Gun bumped. Approaching the first turn, Bobby Bound, Fancy Moss and Adam's Gun bumped, checking Fancy Moss and Adam's Gun. On the second turn Lashing Storm faltered. Entering the home straight Fancy Moss, Cheeky Ella and Dolly Dyer bumped, checking Dolly Dyer. Lashing Storm underwent a post-race veterinary examination which revealed the greyhound to have a fractured right hock and was subsequently euthanized. A post-race swab sample was taken from Bobby Bound, the winner of the event.

RACE 6 – CURTAINS AND BLINDS GRADE 4 515m

Asgard Warrior, Kinloch's Fox, Regent Assassin and Buckle Up Jones were slow out. Soon after the start Buckle Up Jones and Regent Assassin bumped, checking Buckle Up Jones which then stumbled. Approaching the first turn Asgard Warrior, Lady Rappa and Kinloch's Fox bumped, checking Lady Rappa. On the first turn Asgard Warrior faltered, then crossed wide checking Take Guard. Entering the back straight Buckle Up Jones checked off the heels of Lady Rappa. Asgard Warrior underwent a post-race veterinary examination and was found to have a fractured right hock and was subsequently euthanized.

RACE 7 – GREAT NORTHERN SUPER CRISP MIXED 2/3 515M

Soon after the start Glenrea Target, Quiet Bay, Simpsons Bay, Lucky Nineteen and Furious Floss bumped, checking Simpsons Bay, Lucky Nineteen and Furious Floss. In the front straight Storm Chief, Quiet Bay and Glenrea Target bumped. Approaching the first turn Lucky Nineteen and Furious Floss bumped, checking Furious Floss. Shortly after, Quiet Bay and Glenrea Target bumped. On the second turn Quiet Bay checked off the heels of Glenrea Target. On the third turn Glenrea Target and Lucky Nineteen bumped. On the home turn Lucky Nineteen checked off the heels of Glenrea Target.

RACE 8 – A TOTAL CAR RENTALS GRADE 5(2) 515M

Wynburn Rose was slow out. Soon after the start New Romance crossed to the rail, checking Wynburn Rose. Approaching the first turn Drum Grohl and Nine Squared bumped. On the first turn Madam Anne, Drum Grohl and Nine Squared bumped. As a result New Romance galloped on the heels of Nine Squared, checking both greyhounds. In the back straight Nine Squared and Baroque Inn bumped, checking Nine Squared. Wynburn Rose raced wide throughout. Wynburn Rose underwent a post-race veterinary examination and no apparent injury could be detected. Trainer Mr B Deverell stated that in his opinion Wynburn Rose is not suited to the Launceston tracks and it was now his intention to race the greyhound at either Devonport or Hobart. A post-race swab sample was taken from Assembly, the winner of the event. When questioned on the apparent improved performance of Assembly, trainer Mr A Bullock stated that the greyhound was able to obtain an interference free run tonight whereas in its most recent starts it had suffered interference and was unable to gain clear racing room.

Priority Punter was slow out. Soon after the start Kokomo Beach crossed to the rail checking Rock On Rolla. At the same time, Moto Warrior and Magic Moz bumped. Approaching the first turn Joe Emery, Rock On Rolla, Priority Punter, Moto Warrior and Magic Moz bumped, checking Rock On Rolla and Magic Moz. Approaching the home turn Rock On Rolla, Joe Emery and Priority Punter bumped,

checking Joe Emery. On the home turn Rock On Rolla checked off the heels of Compelling, checking Priority Punter and Moto Warrior. In the home straight Joe Emery checked off the heels of Rock On Rolla.

RACE 10 – LUXBET RACING CENTRE GRADE 5(3) 515M

Soon after the start Almachino and Real Stylist bumped, checking Almachino. At the same time, Bearville Wigi and Turbo Riley bumped. Shortly after, Almachino and Turbo Riley bumped. Approaching the first turn Low Flying Plane, Turbo Riley and Real Stylist bumped, checking Real Stylist, Almachino, Bearville Wigi, Turbo Riley and Nekhbet. Shortly after, Yogo Xena checked off the heels of Keep Ya Looks. At the same time, Low Flying Plane and Keep Ya Looks bumped. On the first turn Keep Ya Looks and Low Flying Plane bumped. On the second turn Keep Ya Looks and Low Flying Plane bumped on several occasions. Entering the back straight Keep Ya Looks and Low Flying Plane bumped, checking Low Flying Plane and Yogo Xena. In the back straight Yogo Xena checked off the heels of Keep Ya Looks. On the third turn Yogo Xena checked off the heels of Keep Ya Looks. Entering the home straight Low Flying Plane, Bearville Wigi and Yogo Xena bumped, checking Bearville Wigi. In the home straight Keep Ya Looks and Real Stylist bumped.

GENERAL

Regrette Rien completed a Stewards satisfactory trial as the greyhound had not raced for in excess of 6 months pursuant to LR31.3.

Weighing 28.2 and beginning from box 3, Regrette Rien completed the 278 metre trial distance in a time of 16.45. Regrette Rien has been cleared to race at all tracks.

Trainer Mr A Bullock pleaded guilty to a charge under GAR 68(o) Negligence, the particulars of the charge being that Mr Bullock failed to retrieve his greyhound Boozy Rose from its race kennel subsequent to the race meeting at the HGRC on 8 December 2016, After considering submissions on penalty Mr Bullock was fined the sum of \$150.
