### RACE 1 – INCITEC PIVOT 3YO MAIDEN – 1400 METRES

**Biscay Barb** – Rider Sigrid Carr reported the gelding raced greenly in the home straight.

**Shivida** – Raced wide without cover throughout.

**In Bloom** – Slow into stride.

**Mag Wheels** – A post-race veterinary examination revealed the filly to have been galloped on on the off-hind leg.

**Tyalla** – Commenced to lose ground from the 600 metres. Rider Ismail Toker explained that the filly is one-paced and would be better suited over a further distance. Tyalla underwent a post-race veterinary examination and no abnormalities could be detected. Connections advised they will evaluate the filly's racing future.

**Husson's Kiss** – Rider Georgie Catania reported the filly had a tendency to lay in and race greenly throughout.

### RACE 2 – T A BRICKNELL MAIDEN – 1400 METRES

**George's Gambol** – Raced wide without cover throughout.

**Silver Reset** – Rider Chris Graham was reprimanded for using his whip on six occasions prior to the 100 metres. Rider Chris Graham was fined \$150 under AR144 for failing to weigh in for second place.

**Fashion Tycoon** – Raced wide without cover throughout, laid in near the 400 metres and momentarily steadied off heels.

**Tilmosa** – Slow into stride.

**Liffey Lad** – Inquiry adjourned into the reasons for losing position passing the 1200 metres due to race footage being unavailable.

### **RACE 3 – QUEENS ARMS HOTEL BM62 HANDICAP – 1400 METRES**

**Lazy Democracy** – Slow into stride. Prior to correct weight, rider Raquel Clark viewed the official photo finish.

**Dehughes** – Momentarily tightened and had to be steadied near the 400 metres. Rider Shuji Amano stated that the gelding should benefit from the run.

**Willby Rules** – Raced wide without cover throughout. Rider Davie Pires stated the gelding failed to respond to his riding from the 400 metres.

**Schillie Billie** – Over-raced in the early stages when being restrained to obtain cover.

**Cuban Missile** – Shifted in near the 400 metres. Rider Sherry Barr reminded of her obligations to ensure she is fully clear when shifting ground.

### **RACE 4 – SUES OF INVERMAY BM72 HANDICAP – 1400 METRES**

**Minute Repeater** – Rider Stephanie Thornton reported that something felt amiss with the gelding. Subsequent to the race meeting Trainer Yassy Nishitani stated that the gelding had pulled up well and would continue on with its preparation.

**Beaufort Lad** – Held up for clear racing room near the 500 metres.

**O'Reillys Geegee (NZ)** – Slow into stride (1L). Rider Georgie Catania reported that something may have been amiss with the gelding's action. O'Reillys Geegee underwent a post-race veterinary examination and no abnormalities could be detected.

**Perplexing** – Raced wide without cover throughout.

**Watch Over Me** – Over-raced in the early and middle stages.

### **RACE 5 – TASMANIAN LIVESTOCK SERVICES MAIDEN – 1800 METRES**

**Northern Command** – Rider Bulent Muhcu reprimanded for using his whip on 6 occasions prior to the 100 metres.

**On A String** – Momentarily held up approaching the 100 metres. Rider Sigrid Carr was fined \$200 under AR137A(5)(a)(ii) for using her whip 7 times prior to the 100 metres. When questioned on the improved performance of On A String, trainer John Blacker explained that the gelding was more suited to this race than in its most recent starts and the addition of a visor and a tongue tie may have had an effect on the horse's performance.

**Totally Wicked** – Over-raced in the middle stages.

**Vivre Star** – Tightened and became unbalanced between **Totally Wicked** and **Heaps Of Heart** near the 600 metres.

**Intriguingly** – Over-raced in the middle stages.

**Stem Cell** – Underwent a post-race veterinary examination and no abnormalities detected.

### **RACE 6 – CRESSY CHAFF CUTTERS JIM OSBORNE LONGFORD CUP – 1800 METRES**

**Demons Run** – Prior to correct weight, connections viewed the official photo finish.

**Miss It And A Bit** – Rider Sherry Barr plead guilty to a charge under AR137(a) Careless Riding, the particulars being near the 400 metres she permitted her mount to shift in when insufficiently clear of **Zigold**, resulting in Zigold being checked and almost dislodging rider Raquel Clark. As a result, **Smoke**

**'n' Whisky** which was following, was checked. Rider Sherry Barr's licence to ride in races was suspended for two Tasmanian race dates, commencing midnight 6 January 2017 and expiring midnight 14 January 2017. Miss It And A Bit underwent a post-race veterinary examination and no abnormalities detected.

**Demons Run** – Momentarily Inconvenienced near the 400 metres.

**Smoke 'n' Whisky** – Over-raced passing the 1000 metres. Checked passing the 400 metres.

**Valdez** – Rider Bulent Muhcu was reprimanded for using his whip on 6 occasions prior to the 100 metres.

**Zigold** – Checked passing the 400 metres, nearly dislodging rider Raquel Clark. Underwent a post-race veterinary examination and no abnormalities detected.

**King Manu** – Held up for clear racing room passing the 400 metres.

### **RACE 7 – WOOLMERS ESTATE BICENTENNIAL BM62 HANDICAP – 1800 METRES**

**Big Pegg** – Rider David Pires explained that it was his intention to ride the mare further forward however due to the early pace on his inside he was unable to take up a forward position with cover and he elected to restrain which left him further back than intended.

**Sh'Bourne Dylaca** – Overraced in the middle stages.

**Hoffsetter** – Overraced in the early and middle stages. Hung out near the 400 metres and had to be restrained away from the heels of **Cosmic Angel**.

**Cosmic Angel** – Rider Sigrid Carr was fined \$200 under AR137A(5)(a)(ii) for using her whip 8 times prior to the 100 metres.
