**RACE 1 – A TOTAL CAR RENTALS - GRADE 6 - 515M**

Bigtime To Excel and Demon Lad were slow out. Soon after the start Buckle Up Tassie and Smooth Jinx bumped. At the same time Vrontios and Demon Lad bumped. In the front straight Marteeny, Buckle Up Tassie and Smooth Jinx bumped, checking Buckle Up Tassie and Smooth Jinx. Approaching the first turn Buckle Up Boston and St. Rocco bumped. At the same time Bigtime To Excel, Buckle Up Tassie and Smooth Jinx bumped, checking Buckle Up Tassie and Smooth Jinx. Approaching the third turn St. Rocco and Vrontios bumped, checking both greyhounds. As a result Bigtime To Excel galloped on the heels of Vrontios, severely checking that greyhound and checking Bigtime To Excel and Demon Lad. Touch Of Silk underwent a post-race veterinary examination and no apparent injury could be detected.

Purdie Shuffle underwent a post-race veterinary examination and no apparent injury could be detected. Fancy Moss underwent a post-race veterinary examination and no apparent injury could be detected. A post-race swab sample was taken from Kinloch's Fox, the winner of the event.

Real Stylist and Frosty's Capable were slow out. On the second turn Real Stylist checked off the heels of Redhot Coles. Entering the back straight Redhot Coles checked off the heels of Adam's Bandit. On the third turn, Redhot Coles and Frosty's Capable bumped, checking Frosty's Capable. Shortly after, Bet On Dud checked off the heels of Real Stylist. Bet On Dud underwent a post-race veterinary examination and no apparent injury could be detected. A post-race swab sample was taken from Bongioletti, the second placegetter in the event.

**RACE 6 – LUXBET.COM RISING STARS HEAT 3 – MIXED 4/5 - 515M**

Lucky Nineteen was slow out. Soon after the start Pure Presence checked off the heels of Princess Roman, checking Runout Babe. Shortly after, Lady Rappa crossed to the rail, checking Adam's Blue Boy and bumped with Runout Babe. At the same time, Pure Presence checked off the heels of Runout Babe and Buckle Up Gnu galloped on the heels of Regent Assassin, checking Regent Assassin. As a result, Regent Assassin dropped back, checking Buckle Up Gnu and Pure Presence. Approaching the first turn Buckle Up Gnu galloped on the heels of Adam's Blue Boy, checking both greyhounds and, as a result, Adam's Blue Boy faltered. On the first turn Lucky Nineteen and Lady Rappa bumped. On the home turn Lucky Nineteen checked off the heels of Runout Babe. Regent Assassin underwent a post-race veterinary examination and no apparent injury could be detected. Adam's Blue Boy underwent a post-race veterinary examination which revealed the greyhound to have a fractured right hock. Adam's Blue Boy was subsequently euthanised. A post-race swab sample was taken from Lady Rappa, the winner of the event.

**RACE 7 – SIMON'S CARPET ONE – MIXED 3/4 - 515M**

Bobby Bound and Bulla's Boy were slow out. Soon after the start Kamikaze Turtle, Winklee Colin and Drum Grohl bumped. In the front straight Drum Grohl and Winklee Colin bumped, checking Winklee Colin. Approaching the first turn Kamikaze Turtle checked off the heels of Misty Fiord. On the first turn Bulla's Boy galloped on the heels of Winklee Colin, checking both greyhounds. Entering the home straight Greysynd Gem and Drum Grohl bumped. In the home straight Bulla's Boy and Winklee Colin bumped.

On the home turn Scorching Lilly, Cheeky Ella and Adam's Gun bumped. Entering the home straight Eliza Dee, Scorching Lilly and Cheeky Ella bumped, checking Scorching Lilly and Bearville Wigi. Approaching the finish Eliza Dee, Cheeky Ella and Adam's Gun bumped. At the same time Scorching Lilly and Almachino bumped. Captain's Call underwent a post-race veterinary examination and no apparent injury could be detected. Stewards spoke to trainer Mr S Rowlands in relation to the poor performance of Captain's Call. Acting on their own observations, viewing the official replays and taking evidence from Mr Rowlands, Stewards were of the opinion that Captain's Call's performance was unsatisfactory after the greyhound trailed the field was uncompetitive throughout the event to be beaten 20-½ lengths in a time of 31.61. Pursuant to GAR71, Captain's Call has been stood down from racing until the completion of a satisfactory trial.

**RACE 10 – CARLTON DRAUGHT – GRADE 5 - 278M**

Swift Mover underwent a post-race veterinary examination and no apparent injury could be detected. Stewards spoke to trainer Mr N Howard in relation to the race manner of Swift Mover over the concluding stages. Acting on their own observations, viewing the official replays and taking evidence from Mr Howard, Stewards were of the opinion that Swift Mover had eased and in doing so had failed to pursue the lure with due commitment throughout the event pursuant to GAR69A(1). Acting under the provisions of GAR69A(2)(a) Swift Mover has been stood down from racing for a period of 28 days at Launceston and until the completion of a satisfactory trial.
