Trainers with multiple runners engaged in any race were questioned as to their intended driving tactics.

RACE 1 – DES & KAY LOGAN MEMORIAL – 1609 METRES

PAUL DONALD which tired to finish distanced underwent a post-race veterinary examination which revealed no apparent abnormalities.

RACE 2 – ERIC REECE MEMORIAL FINAL – 2090 METRES

Driver Sam Rawnsley (IDEN AMRAK) was reprimanded under AR162(1)(j) for failing to maintain his position at the start. IDEN AMRAK was held up rounding the home turn.

GAGGLE COORDINATOR, which was out of position at the start despite the efforts of driver Braden Howlett, will be placed on its last chance in the draw.

ANIMI SUB IGNIS (Rohan Hillier) raced rough under pressure over the concluding stages.

KARALTA BOOMER lost a knee boot on the first turn.

Driver Samantha Gangell (DEMONSTRATIVE) was reprimanded under AR162(1)(j) for failing to maintain her position at the start.

Driver Christian Salter (THATSWHATSHESAID) was reprimanded under AR162(1)(h), for failing to come up into position at the start.

RACE 3 – LUXBET PACE – 2090 METRES

CALL HER JULIE (Rohan Hillier) underwent a pre-race veterinary examination and was passed fit to run. That mare was then out of position at the start despite the efforts of driver Rohan Hillier and has been placed on its last chance in the draw. CALL HER JULIE then tired over the concluding stages and will now be placed on its last chance to race truly.

SIOUX WEST NZ (Braden Howlett) which tired after leading underwent a post-race veterinary examination which revealed no apparent abnormalities.

RUSTY RED COMET (Rodney Ashwood) which broke free of interference entering the home straight has now been placed on its last chance to race truly.

LUWAY WINNIE (Tim Yole) which tired over the concluding stages has been placed on its last chance to race truly.

INGLIS (Paul Ashwood) has now been placed back in the mobile draw. The gelding which tired has now been stood down from racing for 10 days until completion of a satisfactory trial.

RACE 4 – RELISH CATERING PACE – 1609 METRES

WHATELSUGOT (Tim Yole) broke in the score up and was out of position at the start and tailed the field taking no competitive part in the event and has now been placed out of the draw.

DEPLOY hung out under pressure over the concluding stages.

Prior to the All Clear being given driver Sam Rawnsley (CHARLIE JAMES) lodged a protest against ONEMORELAUGH (Matthew Cooper) being declared the second placegetter on the grounds of interference between the 400 metre and 300 metres. After hearing evidence from drivers Sam Rawnsley and Matthew Cooper, viewing the official race replays and acting on their observations, Stewards were comfortably satisfied that the extent of the interference which occurred at that stage of the race exceeded the margin between the placegetters at the finish of a Head and, as such, upheld the protest. All Clear was then given on the amended numbers with CHARLIE JAMES being promoted to second place and ONEMORELAUGH being placed third. Driver Sam Rawnsley was reprimanded under AR168(1)(a) for the manner in which he shifted ground leading the back straight on the final occasion. ONEMORELAUGH has been placed on its last chance to race truly for hanging.

RACE 5 – SMITHAWARDS HOBART PACING CUP FINAL – 3060 METRES

All drivers in this event wore black armbands in memory of the late Doug McKillop.

Connections of BIG GORILLA advised that their intention was, if possible, to drive the gelding with a forward sit in contrast to previously notified tactics of leading. Stewards approved the change of tactics. The gelding which then galloped out has now been placed out of the draw. BIG GORILLA which also tired over the concluding stages has now been placed on its last chance to race truly.

ALL I CAN BE (Tim Yole) was fractious before the start and delayed the start. The gelding which then also stood flat footed will now be placed out of the draw for standing start events. ALL I CAN BE tired over the concluding stages and has been placed on its last chance to race truly.

BLACKJACKHANOVER (Paul Hill) which galloped out has been placed on its last chance in the draw.

JUST KNEW (Gareth Rattray) which galloped out has now been placed out of the draw.

IDLE HANDS (Sam Rawnsley) galloped out and will continue out of the draw. The gelding which then tired to finish distanced underwent a post-race veterinary examination which revealed no apparent abnormalities. IDLE HANDS has been stood down from racing for 10 days until completion of a satisfactory trial.

REMEMBER JOE (Rodney Ashwood) tired badly over the concluding stages and a post-race veterinary examination revealed no apparent abnormalities. The gelding has been stood down from racing for 10 days and completion of a satisfactory trial.

SOMETHING EYRE NZ (Adrian Duggan) tired from the bell before then breaking at the entrance to the home straight and then galloped for the remainder of the race. SOMETHING EYRE NZ underwent a post-race veterinary examination which revealed a high heart rate post-race and a slow recovery rate. The gelding has been stood down from racing pending a veterinary certificate of fitness to race.

Post-race swab samples were taken from IM BARNEY RUBBLE NZ, winner of the event.

RACE 6 – TALBOT HOTEL CLAIMER – 2090 METRES

There were no claims in this race.

REGAL STRIDE NZ (Tim Yole) unsuccessfully contested the lead in the back straight on the first occasion.

SKY TOWER (Mark Yole) which galloped out has been placed out of the draw.

CYRILFROMTHEPOCKET (John Walters) which galloped out will continue to be placed out of the draw. CYRILFROMTHEPOCKET was then held up rounding the home turn.

WRONGLY ACCUSED (Paul Ashwood) which was fractious before the start caused a delay to the start. As the start was effected, the gelding then reared and galloped out and will continue right out of the draw. It will also be stood down from standing start races pending the completion of a satisfactory stand start trial.

RACE 7 – SHADFORTHS FINANCIAL GROUP PACE – 2090 METRES

ROCKBANK DANCER (Christian Salter) broke free of interference in the home straight and has now been placed on its last chance to race truly.

Driver Ricky Duggan (I AM CAMELOT) was fined \$100 under the provisions of AR162(1)(y) for failing to comply with minimum sectional requirements for the event.

MY ARTHUR BEE (Samantha Gangell) pulled hard in the score up.

RACE 8 – ERIC REECE MEMORIAL CONSOLATION – 2090 METRES

Prior to the event the connections of LORD STARK NZ advised their intention to attempt to lead with the gelding circumstances permitting due to the small field and favourable draw. Stewards approved the change of tactics and after showing enough gate speed to cross UCARNTBEATAMINT, LORD STARK NZ was then headed off by ART EDITION (Chris Viney) and then trailed the leader during the run to finish in third place.

UCARNTBEATAMINT (Paul Hill) pulled hard in the score up and then hung in.

Driver Chris Viney (ART EDITION) was fined \$100 under the provisions of AR162(1)(y) for failing to comply with minimum sectional time requirements for the event.
