metres**RACE 1 – LUXBET CLUB XTRA GRADE 6(1) – 515 METRES**

Metanoia Franko was slow out. Soon after the start Vrontios and Zulu Knock's bumped. In the front straight Buckle Up Clanga and Call Me Charlie bumped. Approaching the first turn Maharani, Excel To Burn, Buckle Up Clanga and Call Me Charlie bumped, checking Excel To Burn, Call Me Charlie and Buckle Up Clanga. At the same time, Vrontios and Metanoia Franko bumped, checking Metanoia Franko which contacted the rail. On the first turn Excel To Burn and Zulu Knock's bumped. On the second turn Buckle Up Clanga and Zulu Knock's bumped, checking Zulu Knock's. Entering the back straight Buckle Up Clanga and Zulu Knock's bumped. At the same time, Call Me Charlie and Excel To Burn bumped, checking Excel To Burn. Approaching the third turn Buckle Up Clanga, Excel To Burn and Metanoia Franko bumped, checking Excel To Burn and Metanoia Franko. On the home turn Excel To Burn and Metanoia Franko bumped. Metanoia Franko underwent a post-race veterinary examination and no apparent injury could be detected. Buckle Up Clanga underwent a post-race veterinary examination and no apparent injury could be detected. Excel To Burn underwent a post-race veterinary examination and no apparent injury could be detected. Stewards spoke to trainer Mr R Watts in relation to the race manner of Excel To Burn rounding the home turn. Acting on their own observations, viewing the official replays and taking evidence from Mr Watts, Stewards were of the opinion that Excel To Burn had turned its head outwards towards Buckle Up Clanga however could not be satisfied that the greyhound had made head or muzzle contact. In doing so Stewards were satisfied that Excel To Burn had failed to pursue the lure with due commitment throughout the event. Pursuant to GAR 69A(1), acting under the provisions of GAR69A(2)(a), Excel To Burn has been stood down from racing for a period of 28 days at Launceston and until completion of a satisfactory trial.

Shortly after, Yakan De Kahn, Out Of Traction and Offen Charles bumped, checking all three greyhounds. On the first turn Buckle Up York crossed wide, checking Offen Charles. At the same time, Bigtime To Excel checked off the heels of Out Of Traction. Entering the back straight Bigtime To Excel checked off the heels of Offen Charles. On the third turn Buckle Up York and Yakan De Kahn bumped, severely checking both greyhounds. Offen Charles raced wide throughout the event. Buckle Up York underwent a post-race veterinary examination and no apparent injury could be detected. Yakan De Kahn underwent a post-race veterinary examination and no apparent injury could be detected. Oh So Nice underwent a veterinary examination after suffering interference in the catching pen and no apparent injury could be detected.

On the second turn Half Century checked off the heels of Missile Ben, severely checking itself and Oliver Queen. Entering the back straight Tah Jen and Oliver Queen bumped. On the home turn Tee Cee Benny and Lashing Freda bumped. Approaching the finish, Buckle Up Labi, Tee Cee Benny and Missile Ben bumped. Tah Jen underwent a post-race veterinary examination and no apparent injury could be detected. Oliver Queen underwent a post-race veterinary examination which revealed the greyhound to have muscle soreness to the left quadracep. Oliver Queen has been stood down from racing for a period of five days.

Entering the front straight Queen Matilda, Regent Assassin and Winklee Colin bumped, checking Winklee Colin. At the same time, Lashing Jackson and Surf The Artic bumped. Shortly after, Lashing Jackson, Surf The Artic, Queen Matilda and Regent Assassin bumped, checking Regent Assassin and Surf The Artic. In the front straight Queen Matilda and Lashing Jackson bumped. On the fourth turn Lashing Jackson checked off the heels of Winklee Colin. Approaching the home turn Regent Assassin checked off the heels of Buckle Up Gnu, checking Surf The Artic. Winklee Colin underwent a post-race veterinary examination which revealed the greyhound to be showing signs of a left-hind track leg however no stand down period was applied. Surf The Artic underwent a post-race veterinary examination and no apparent injury could be detected. Brusha Borne underwent a post-race veterinary examination and no apparent injury could be detected.

On the third turn Pure Presence and Dilston Rebel bumped, checking Dilston Rebel. Dilston Rebel underwent a post-race veterinary examination and no apparent injury could be detected. Shack View underwent a post-race veterinary examination which revealed the greyhound to have a minor seroma on the point of the left elbow. Shack View has been stood down from racing for a period of five days. Kinloch's Fox underwent a post-race veterinary examination which revealed the greyhound to have soreness to the right shoulder. Kinloch's Fox has been stood down from racing for a period of five days. A post-race swab sample was taken from Pure Presence, the winner of the event.

Dilston Loch underwent a post-race veterinary examination and no apparent injury could be detected. Pop An' Kobi underwent a post-race veterinary examination which revealed the greyhound to have soreness to the right wrist. Pop An' Kobi has been stood down from racing for a period of seven days. Trainer/Representative Mrs R Johnson was reprimanded pursuant to GAR48 for failing to provide a catcher for one of her runners in this event.
