RACE 1 – LUXBET – GRADE 5(1) – 461M

Vrontios was slow out. Soon after the start Sol Invictus, Family Pick and Ziping Elvis bumped, checking Ziping Elvis. Soon after, Ziping Cash crossed to the rails checking Sol Invictus, Family Pick and Windfast Duck. In the back straight Windfast Duck and Sol Invictus bumped. Soon after, Ziping Cash and Windfast Duck bumped, checking Windfast Duck and Sol Invictus. On the first turn Windfast Duck and Sol Invictus bumped, checking Sol Invictus. Soon after, Niki's Lad checked off the heels of Vrontios. Sol Invictus raced wide in the home straight. Ziping Elvis underwent a post-race veterinary examination and was found to have an injured dew claw which was subsequently removed. Ziping Elvis has been stood down from racing for a period of 3 days.

On the first turn Posh Faith and Baroque Inn bumped, checking Baroque Inn. Soon after, Terra Vista and Posh Faith bumped, checking Terra Vista and Baroque Inn. Soon after, Coffee Elizabeth and Baroque Inn bumped, checking Bit Hot Rusty. Approaching the home turn Triple Century and Lisheen bumped. Soon after, Lisheen and Rock On Rolla bumped. On the home turn Triple Century marred the running of Lisheen. Triple Century underwent a post-race veterinary examination and no apparent injury could be detected. Stewards spoke to trainer Mr A Bullock in relation to the racing manners of Triple Century on the home turn. Acting on their own observations, viewing the official replays and taking evidence from Mr Bullock, Stewards were of the opinion that Triple Century had turned its head outwards making head or muzzle contact with Lisheen and by doing so had marred the running of that greyhound pursuant to GAR 69(1). Acting under the provisions

of GAR69(2)(a), Triple Century has been stood down from racing for a period of 28 days – Hobart only and until the completion of a satisfactory trial.

Approaching the first turn Devil's Gullet and Still Working bumped. On the first turn Devil's Gullet checked off the heels of Still Working, checking Devil's Gullet and Grease Explosion. Soon after, Redhead Relton checked off the heels of Atomic Tecoma. In the home straight Unleash and Devil's Gullet bumped. Approaching the winning post Unleash galloped on the heels of Devil's Gullet, checking both greyhounds. Devil's Gullet underwent a post-race veterinary examination which revealed the greyhound to have muscle soreness to its left hind leg. Devil's Gullet has been stood down from racing for a period of 3 days.

On the home turn Katey Roman and Penny's Roman bumped. Approaching the winning post Katey Roman and Penny's Roman bumped. At the same time Long View Belle and Miss Stylist bumped. Halo Lee raced wide in the home straight.

On the home turn Bet On Dud and Duck In Town bumped. Approaching the winning post Kandara Kid checked off the heels of Drury Lane. At the same time, Duck In Town and Urana Gold bumped.

Soon after, Thumb Print checked off the heels of Eliza Dee, severely checking Thumb Print and checking Winklee Colin, Tah Jen and Dr. Trojan. Thumb Print underwent a post-race veterinary examination and no apparent injury could be detected.

GENERAL

Licensed Trainer Mr P Cassidy was reprimanded under GAR48 for failing to fulfil his obligations to be a catcher in Race 2.

Licensed trainer Mr W Howells was reprimanded under GAR86(o) for negligence in that when parading to the boxes in Race 9, he was negligent at the conclusion of the stir when his greyhound slipped from his control on the lead and ran up the track a distance of approximately 30 metres before being caught adjacent to the stationary lure. After taking evidence from Starting Steward Mr G Cooper and Trainer Mr Howells, stewards were satisfied with the explanation given by Mr Howells. Taking into account his experience, length of time in the industry and genuine remorse, Stewards issued a reprimand.
