### **QUALIFYING TRIAL 1 - METRES**

Buckle Up Tilda and Tee Cee Benny were slow out. Soon after the start Posh Renee and Slip Streamer bumped. At the same time, Unleash and Jinx bumped, checking Unleash. In the back straight Posh Renee checked off the heels of Slip Streamer. On the first turn Unleash galloped on the heels of Posh Renee, severely checking Posh Renee and checking Unleash. On the home turn Slip Streamer checked off the heels of Buckle Up Tilda, checking Unleash. Posh Renee underwent a post-race veterinary examination and no apparent injury could be detected.

### **QUALIFYING TRIAL 2 - METRES**

Platinum Judy was a late scratching at 11.45am after the greyhound was examined by the veterinary surgeon and was found to be in season. Pursuant to GAR24(4) Platinum Judy has been stood down from racing for a period of 28 days. Soon after the start Buckle Up Cooney crossed to the rail, checking Buddy Goode, Zipping Cash and Shogun Steel. On the first turn Missile Ben faltered. On the home turn Double Dose checked off the heels of Chop A Log, checking Buckle Up Cooney. Missile Ben underwent a post-race veterinary examination which revealed the greyhound to have a fractured right hock and was subsequently euthanised.

Yogo Xena was slow out. Soon after the start Marciana and Amazing Black bumped. On the first turn Marciana and Assembly bumped, checking Assembly. On the home turn Yogo Xena and Queen Matilda bumped, checking Queen Matilda and Assembly. Marciana and Brusha Borne raced wide in the home straight.

### **QUALIFYING TRIAL 4 - METRES**

Suspect Nargles was slow out. Soon after the start Wicked Turtle, Hello Birdy, Yogo Hara and Morrigan bumped, checking Yogo Hara and Hello Birdy. Shortly after, Wicked Turtle and Morrigan bumped. At the same time Dark Drifter, Hello Birdy and Yogo Hara bumped, checking Hello Birdy. In the back straight Wicked Turtle and Morrigan bumped, checking Morrigan. Approaching the first turn Suspect Nargles checked off the heels of Morrigan and bumped with Hello Birdy. Approaching the home turn Black Rhino and Dark Drifter bumped, checking Dark Drifter and Morrigan. Suspect Nargles raced wide in the home straight.
