Trainer Mr R Watts reported that the greyhound was unsuitable to race due to an injury received in the yard. Tax Man Wins has been stood down from racing for a period of 10 days and until a veterinary certificate confirming the greyhounds condition has been received. Adam's Bandit was a late scratching at 6.45pm due to weight variation pursuant to GAR39(3). Adam's Bandit has been stood down from racing for a period of 10 days. Trainer Mr B Adams was subsequently fined the sum of \$50. Soon after the start Quiet Bay and Dark Casio bumped, checking Quiet Bay. On the first turn Coffee Elizabeth checked off the heels of Buckle Up Beneau. As a result, Buckle Up Beneau carried Quiet Bay wider on the track. On the second turn Bobby Bound and Buckle Up Beneau bumped. Soon after, Buckle Up Beneau galloped on the heels of Perfect Metre, checking Perfect Metre and Buckle Up Beneau. Approaching the third turn Perfect Metre, Buckle Up Beneau and Quiet Bay bumped, checking Buckle Up Beneau and severely checking Quiet Bay. Quiet Bay underwent a post-race veterinary examination and no apparent injury could be detected. Perfect Metre underwent a post-race veterinary examination and no apparent injury could be detected. Soon after, Lil' Miss Marny, Adam's Snow and Zipping Quinsee bumped, checking Adam's Snow. In the back straight Shirley Bass checked off the heels of Pantera Nera. Approaching the third turn Adam's Snow crossed to the rails, checking Wynburn Archer. Approaching the home turn Adam's Snow and Capra Ross bumped, checking Adam's Snow. Wynburn Archer underwent a post-race veterinary examination which revealed muscle soreness to its left fore triceps. Wynburn Archer has been stood down from racing for a period of 7 days. Stewards spoke to trainer Mr B Englund in relation to Wynburn Archer's racing manners throughout the event. After taking evidence from Mr Englund and Steward Mr Peter Hall, acting on their own observations and viewing the official replays, Stewards accepted the injury and gave Wynburn Archer the benefit of the doubt. Trainer B Englund was advised that Wynburn Archer would be closely monitored and a similar performance may result in a stand down.
