**RACE 1 – THE ADVOCATE – GRADE 6(1) – 452 METRES**

Soon after the start Yogi Mac stumbled and lost ground. On the first turn Blue Bombshell, Kickitta Royce, Devil's Gullet and Marciana bumped, checking Blue Bombshell, Kickitta Royce and Devil's Gullet. As a result, Buckle Up Alex checked off the heels of Devil's Gullet and galloped on the heels of Blue Bombshell, severely checking that greyhound and checking Buckle Up Alex. Entering the home straight Yogi Mac and Scully Gregg bumped. Marciana raced wide in the home straight. Blue Bombshell underwent a post-race veterinary examination and no apparent injury could be detected. Yogi Mac underwent a post-race veterinary examination which revealed the greyhound to have a muscle tear to the right hind leg. Yogi Mac has been stood down from racing for a period of 7 days.

**RACE 2 – FOSTER'S LAGER – GRADE 6(2) – 452 METRES**

Frazzle Dazzle, Subiasco Kahn, Blundell and Malawi Breeze were slow out. In the back straight Malawi Breeze and Cosmic Nova bumped. At the same time Subiasco Kahn checked off the heels of Malawi Breeze. Shortly after, Morrigan, Cosmic Nova and Malawi Breeze bumped, checking Cosmic Nova and Morrigan. Approaching the first turn, Subiasco Kahn and Blundell bumped. On the first turn Malawi Breeze checked off the heels of Frazzle Dazzle. Approaching the home turn Malawi Breeze and Cosmic Nova bumped, checking Cosmic Nova. Malawi Breeze raced wide in the home straight.

**RACE 3 – CROWN LAGER – GRADE 6(3) – 452 METRES**

Redhead Relton and Nova Achiever were slow out. Soon after the start Fight To Excel, Buckle Up Boston and Shima Sun bumped, checking Buckle Up Boston. In the back straight One Arm Bandit, Finnigans Way, Shima Sun and Fight To Excel bumped on several occasions. On the first turn Nova Achiever, Fight To Excel, Shima Sun, Finnigans Way and One Arm Bandit bumped, checking Finnigans Way, Shima Sun and Fight To Excel. Shortly after, Finnigans Way and Redhead Relton bumped, checking both greyhounds. On the home turn One Arm Bandit and Nova Achiever bumped. In the home straight Shima Sun and One Arm Bandit bumped. Redhead Relton underwent a post-race veterinary examination and no apparent injury could be detected. Finnigans Way underwent a post-race veterinary examination which revealed the greyhound to have mild thumps. Finnigans Way has been stood down from racing for a period of 3 days. One Arm Bandit underwent a post-race veterinary examination and no apparent injury could be detected.

**RACE 4 – CUB DISTANCE CHAMPIONSHIP HEAT 1 – FFA – 580 METRES**

This was declared a no-race after the lure lost power in the back straight and stopped, resulting in all greyhounds catching the lure. Subsequent to the race all greyhounds underwent veterinary examinations. Buckle Up Beneau revealed the greyhound to have a laceration to its left fore leg. Buckle Up Beneau has been stood down from racing for a period of 3 days. Capra Ross, no apparent injury could be detected. Atomec Tecoma, no apparent injury could be detected. Adam's Gun, no apparent injury could be detected. Casio Lad, no apparent injury could be detected. Half Century, no apparent injury could be detected. Take The Crown, no apparent injury could be detected. Sizzling Bandit, no apparent injury could be detected. As this event was a leg of a series a random draw was conducted to determine which greyhounds were to be eligible to participate further in the series.

**RACE 5 – CUB DISTANCE CHAMPIONSHIP HEAT 2 – FFA – 580 METRES**

The start of this race was amended to 2.02pm due to the lure having to be replaced and tested on a number of occasions. Midnight Bird, Gladis Grice, Frosty's Capable and Whistledown were slow out. Approaching the first turn, Midnight Bird, Gladis Grice, Frosty's Capable and Whistledown bumped, checking Frosty's Capable and Midnight Bird which contacted the rail. Approaching the second turn Midnight Bird checked off the heels of Frosty's Capable. On the first turn Honcho Bound galloped on the heels of Pure Presence, checking both greyhounds. Midnight Bird underwent a post-race veterinary examination and no apparent injury could be detected.

**RACE 6 – CARLTON MID – GRADE 4 – 452 METRES**

High Treason and Chelsea Clarice were slow out. Soon after the start Tinker Ross checked off the heels of Hi Dixie. Shortly after, Chelsea Clarice and Stylish Nic bumped. At the same time, Hi Dixie and Lil' Miss Marny bumped. In the back straight High Treason and Tinker Ross bumped. Approaching the first turn Tinker Ross checked off the heels of High Treason. On the first turn High Treason checked off the heels of Chief Black Gum, checking Hi Dixie, Chelsea Clarice, Stylish Nic and Tinker Ross. On the home turn Hello Freckles checked off the heels of Chief Black Gum. In the home straight Hello Freckles and High Treason bumped. At the same time, Tinker Ross and Chelsea Clarice bumped. Tinker Ross underwent a post-race veterinary examination and no apparent injury could be detected. A post-race swab samples was taken from Lil' Miss Marny, winner of the event.

**RACE 7 – PURE BLONDE – INV – 452 METRES**

Rock On Rolla and Some Tricks were slow out. Soon after the start Mighty Matlock and Rock On Rolla bumped. Shortly after, Mahalo Man, Lisheen and Mighty Matlock bumped, checking Lisheen and Mighty Matlock. In the back straight Posh Fire, Lisheen and Mighty Matlock bumped, checking Posh Fire and Mighty Matlock. On the home turn, Rock On Rolla and Wynburn Hornet bumped, checking Wynburn Hornet.

**RACE 8 – MELBOURNE BITTER – GRADE 5(1) – 452 METRES**

Soon after the start Yappin' Blue, Swift Zorro, Double Dose and Wynburn Toro bumped, checking Double Dose and Wynburn Toro. Shortly after, Gold Lenny, Mavista Falls and Yappin' Blue bumped. On the first turn Windfast Duck checked off the heels Droopy's Dasher, checking Mavista Falls, Yappin' Blue, Wynburn Toro and Double Dose which contacted the rail. Shortly after, Wynburn Toro crossed to the rail, checking Yappin' Blue, Windfast Duck, Mavista Falls and Double Dose and, as result, Mavista Falls faltered. Mavista Falls underwent a post-race veterinary examination which revealed the greyhound to have a fractured left hind hock. Mavista Falls has been stood down from racing for a period of 80 days. Trainer Mr A Bullock advised that the greyhound would now be retired. Double Dose underwent a post-race veterinary examination which revealed the greyhound to have muscle soreness to the right hind quad. Double Dose has been stood down from racing for a period of 5 days.

**RACE 9 – CARLTON DRY LIME – MAIDEN – 452 METRES**

Soon after the start Flyin' Fez, Evanta Nemo, Niko Tecoma and Spring Gully Jet bumped, checking Evanta Nemo and Niko Tecoma. Approaching the first turn Mecato Tecoma checked off the heels of Duckies Empire. On the first turn Spring Gully Jet checked off the heels of Mecato Tecoma. A post-race swab sample was taken from Tecoma Skilda, winner of the event.

**RACE 10 – VICTORIA BITTER – GRADE 5(2) – 452 METRES**

Yakan De Kahn was a late scratching at 11.54am as this greyhound was not presented to kennelling by the prescribed time pursuant to GAR31(2). Acting under the provisions of GAR31(4) Yakan De Kahn has been stood down from racing for a period of 28 days. Trainer Mr G Johnson was subsequently fined the sum of \$100. Dan Road was slow out. In the back straight Chief Hiawatha checked off the heels of Keep Ya Looks. On the first turn Keep Ya Looks checked off the heels of Spec Bennett. At the same time Spec Bennett checked off the heels of Betty La Fae, checking Arugula. Ooaar underwent a post-race veterinary examination and no apparent injury could be detected.

**GENERAL**

Moirai completed a Stewards satisfactory trial as this greyhound was stood down at the Richmond Greyhound Racing Club on 15 June 2016 for marring pursuant to GAR69(1). Weighing 32.8kgs and beginning from box 3, Moirai completed the 452 metre trial distance in a time of 26.57. Moirai has been cleared to race at all tracks except for Richmond.
