RACE 1 – DOWLING MCCARTHY TYRES – GRADE 6(1) – 452 METRES

In the back straight One Arm Bandit crossed to the rail, checking Sooky Jooky and bumped with Cosmic Nova. Approaching the first turn Buckle Up Nel and Cawbourne Drive bumped, checking Buckle Up Nel, Fesco Lass, Cosmic Nova and Sooky Jooky. On the first turn One Arm Bandit galloped on the heels of Cawbourne Era, severely checking both greyhounds. As a result, Cawbourne Era fell, checking Sooky Jooky. Cawbourne Era underwent a post-race veterinary examination which revealed the greyhound to have small abrasions to the hind legs however no stand down period was applied. One Arm Bandit underwent a post-race veterinary examination and no apparent injury could be detected.

RACE 2 – CARLTON DRAUGHT – MAIDEN – 452 METRES

Ted Mustang, Hasta De Kahn and Marteeny were slow out. Soon after the start Hasta De Kahn and Marteeny bumped. On the first turn Mini Moose eased and, as a result, Mini Moose, Ted Mustang, Duckies Empire and Marteeny bumped. On the home turn Hasta De Kahn and Duckies Empire bumped. Entering the home straight Blue Bombshell checked off the heels of Marciana, checking Marteeny. Marciana raced wide throughout the event. Blue Bombshell raced wide in the home straight. Mini Moose underwent a post-race veterinary examination which revealed the greyhound to have a minor abrasion to the right hind foot, however no stand down period was applied. Stewards spoke to trainer Mr B Crawford in relation to the race manners of Mini Moose on the first turn. Acting on their own observations, viewing the official replays and taking evidence from Mr Crawford, Stewards were of the opinion that Mini Moose has eased free of interference and, in doing so, had failed to pursue the lure with due commitment throughout the event pursuant to GAR 69A(1). Acting under the provisions of GAR69A(2)(b), as this was the greyhound's second offence, Mini Moose has been stood down from racing for a period of 3 months at all tracks and until the completion of a satisfactory trial.

RACE 3 – THE ADVOCATE – GRADE 6(2) – 452 METRES

Captain Red was slow out. In the back straight Cosmicly Baroque and Devil's Den bumped. Approaching the first turn Stylish April, Nova Achiever and Sequoyah Kahn bumped. Shortly after, Sequoyah Kahn, Cosmicly Baroque and Devil's Den bumped. On the first turn Nova Achiever, Sequoyah Kahn and Cosmicly Baroque bumped, checking Sequoyah Kahn. On the home turn Devil's Den and Captain Red bumped. Entering the home straight Captain Red and Nova Achiever bumped, checking Nova Achiever.

RACE 4 – SEBA SHEETMETAL – GRADE 5(1) – 452 METRES

Whistledown and Black Fesco were slow out. Soon after the start Tacos and Black Fesco bumped, checking Tacos. In the back straight Dark Drifter and Whistledown bumped. Approaching the first turn Dark Drifter checked off the heels of Whistledown. On the first turn Zipping Hooch and Country Helen bumped, checking Zipping Hooch and severely checking Country Helen. As a result, Dark Drifter was checked. Shortly after, Whistledown checked off the heels of Zipping Hooch. Approaching the home turn Tacos checked off the heels of

Country Helen. On the home turn Country Helen and Dark Drifter bumped. Entering the home straight Country Helen and Tacos bumped. Hi Dixie raced wide in the home straight. Dark Drifter underwent a post-race veterinary examination and no apparent injury could be detected. Country Helen underwent a post-race veterinary examination which revealed the greyhound to have minor abrasions to the inside of the right hock, however no stand down period was applied. Tacos underwent a post-race veterinary examination and no apparent injury could be detected.

RACE 5 – GREYHOUND ADOPTION PROGRAM TASMANIA – GRADE 5 – 580 METRES

Winsome Ryder and Casio Lad were slow out. Soon after the start Bounding Boomer and Tah Stella bumped. On the first turn Adam's Gun, Baci De Kahn, Tah Stella, Arugula and Le Baz bumped, checking Tah Stella, Baci De Kahn and Adam's Gun. As a result, Winsome Ryder and Bounding Boomer were checked.

RACE 6 – LUXBET LUXDIV – GRADE 4 – 452 METRES

Frosty's Capable was slow out. Soon after the start Justifia, Jack's Missile and Keep Ya Looks bumped, checking Jack's Missile. In the back straight Kamikaze Turtle and Jadeite bumped. Approaching the first turn Kamikaze Turtle and Jadeite bumped, checking both greyhounds. On the first turn Our Mate Jake galloped on the heels of Justifia, checking both greyhounds. As a result, Jadeite checked off the heels of Justifia. Approaching the home turn Kamikaze Turtle and Justifia bumped. On the home turn Kamikaze Turtle and Justifia bumped. Entering the home straight Frosty's Capable and Jadeite bumped. Approaching the finish Frosty's Capable and Jack's Missile bumped. Justifia underwent a post-race veterinary examination and no apparent injury could be detected. Our Mate Jake underwent a post-race veterinary examination and no apparent injury could be detected. A post-race swab sample was taken from Keep Ya Looks, winner of the event.

RACE 7 – CITY OF DEVONPORT CUP – BEST 8 – 452 METRES

Wynburn Tootie and Katey Roman were slow out. Soon after the start Cosmic Heir, Locknane Eve and Dilston Delight bumped. Shortly after, Dilston Delight and Wynburn Tootie bumped. In the back straight Dilston Delight and Locknane Eve bumped, checking Locknane Eve. Approaching the first turn Senor Slamma crossed to the rail, checking itself, Prescribe, Dilston Delight and Locknane Eve which contacted the rail. On the first turn Dilston Delight checked off the heels of Senor Slamma. Locknane Eve underwent a post-race veterinary examination which revealed the greyhound to have minor abrasions and bruising to the left metatarsals. Locknane Eve has been stood down from racing for a period of 14 days. A post-race swab sample was taken from Cosmic Heir, winner of the event.

RACE 8 – CROWN LAGER – MIXED 3/4 - 452 METRES

Happy Jeff, Bound On Boomer and High Treason were slow out. Soon after the start Santa Claws and Bound On Boomer bumped, checking Bound On Boomer. On the first turn High Treason, Two Bills, Droopy's Jacket and Santa Claws bumped, checking Two Bills, Droopy's Jacket and Santa Claws. Approaching the home turn Santa Claws and Droopy's Jacket bumped. Bound On Boomer underwent a post-race veterinary examination and no apparent injury could be detected.

RACE 9 – SIMONS DESIGN CENTRE – GRADE 5(2) – 452 METRES

Malawi Breeze, Manila Blue and Jouser were slow out. In the back straight Malawi Breeze checked off the heels of Manila Blue. Approaching the first turn Jouser crossed to the rail, checking Pickled Tink, Malawi Breeze and Manila Blue which contacted the rail. On the first

turn Bongioletti, Drum Grohl, Joster and Malawi Breeze bumped, checking Joster and Malawi Breeze. Shortly after, Platinum Cye and Bongioletti bumped, checking Bongioletti. Manila Blue underwent a post-race veterinary examination and no apparent injury could be detected.

RACE 10 – GORACINGTASMANIA.COM.AU – GRADE 5(3) – 452 METRES

Test Pilot was slow out. Soon after the start Dan Road and Social Sally bumped. In the back straight Dan Road and Amazing Black bumped. As a result, Waddlesworth checked off the heels of Amazing Black. On the first turn Dan Road, Kinloch Country and Amazing Black bumped, checking all three greyhounds. As a result, Waddlesworth checked off the heels of Dan Road. Approaching the home turn Dan Road and Test Pilot bumped, checking Test Pilot and Waddlesworth. On the home turn Kinloch Country checked off the heels of Amazing Black. Social Sally raced wide rounding the home turn. In the home straight Buckle Up Labi checked off the heels of Social Sally. Approaching the finish Social Sally and Droopy's Dasher bumped.
