Approaching the home turn Fesco Lass checked off the heels of Yogi Mac. In the home straight Lest We and Smooth Jinx bumped on several occasions. Stylish April and Cosmicly Baroque raced wide in the home straight.

Entering the home straight, Honest Rosie checked off the heels of Family Digger. In the home straight Dangerous Liaison and Whip Carter bumped. Wicked Turtle, Dangerous Liaison, Whip Carter and Honest Rosie all raced wide in the home straight. Weona Vee underwent a post-race veterinary examination and no apparent injury could be detected. Stewards spoke to trainer Denis Wood in relation to the racing manners of Weona Vee approaching the first turn. Acting on their own observations, viewing the official patrol films and

taking evidence from Mr Wood, stewards were of the opinion that Weona Vee had eased and by doing so had failed to pursue the lure with due commitment throughout the event. Pursuant to GAR69A(1), acting under the provisions of GAR69A(2)(a), Weona Vee has been stood down from racing for a period of 28 days and until the completion of a satisfactory trial. Duckies Empire underwent a post-race veterinary examination and no apparent injury could be detected. Shanlyn Poppy underwent a post-race veterinary examination and no apparent injury could be detected.
