RACE 1 – CURTAINS & BLINDS – GRADE 5 – 278 METRES

Kath Emery, Country Greg, Provenance and Call Me Charlie were slow out. In the back straight, Provenance, Country Greg and Kath Emery bumped, checking Kath Emery which contacted the rail. On the first turn Boozy Rose, Sacred Witch and Provenance bumped, severely checking Sacred Witch, checking Boozy Rose, Lahinch, Country Greg and then severely checking Destiny's Gem and Call Me Charlie. On the home turn, Kath Emery checked off the heels of Country Greg. Approaching the finish Destiny's Gem and Call Me Charlie bumped. Sacred Witch underwent a post-race veterinary examination and no apparent injury could be detected. Kath Emery underwent a post-race veterinary examination and no apparent injury could be detected.

RACE 2 – KINGSLEY JARMAN FENCING – INV – 278 METRES

Lapland was slow out. Soon after the start Wynburn Hornet, Dilston Delight, Lisheen and Chelsea Clarice bumped. Approaching the first turn Lyncar Jerry checked off the heels of Dilston Loch. On the first turn Dilston Loch, Chelsea Clarice and Dilston Delight bumped, checking Dilston Delight and, as a result, Wynburn Hornet was severely checked. Shortly after, Lyncar Jerry crossed wide, checking Chelsea Clarice and Dilston Delight and, as a result, Lisheen checked off the heels of Dilston Delight. On the home turn, Chelsea Clarice and Dilston Delight bumped. In the home straight Chelsea Clarice and Dilston Delight bumped, checking Dilston Delight. Wynburn Hornet underwent a post-race veterinary examination and no apparent injury could be detected.

RACE 3 – LAUNCESTON VETERINARY HOSPITAL LAUNCESTON BREEDER – SE – 515 METRES

Winklee Apache turned in the boxes and, as a result, was very slow out. Quintessa was slow out. Soon after the start Ricson Flyer and Diamond Lass bumped, checking Diamond Lass. Approaching the first turn Metanoia Franco and Kalaway Cobs bumped, checking both greyhounds. On the second turn Metanoia Franco galloped on the heels of Kalaway Cobs, checking both greyhounds and, as a result, Quintessa was checked. Entering the back straight Metanoia Franco and Kalaway Cobs bumped, checking Kalaway Cobs. On the third turn Slip Streamer checked off the heels of Ricson Flyer. Entering the home straight Slip Streamer checked off the heels of Ricson Flyer. Winklee Apache underwent a post-race veterinary examination and no apparent injury could be detected. Stewards spoke to trainer Mr E Howard in relation to the box manners of Winklee Apache. Acting on their own observations, viewing the official replays, and taking evidence from Mr Howard, Stewards were of the opinion that Winklee Apache had turned in the boxes, resulting in the greyhound being very slow out and tailing the field throughout the event. Winklee Apache has been stood down from racing until the completion of a satisfactory trial pursuant to GAR52(1). Kalaway Cobs underwent a post-race veterinary examination and no apparent injury could be detected. A post-race swab sample was taken from Woosha, winner of the event.

RACE 4 – LAUNCESTON VETERINARY HOSPITAL LAUNCESTON BREEDER – SE – 515 METRES

Winklee Terror was slow out. Soon after the start Trumpence and New Tears Angel bumped. At the same time, Fesco Man checked off the heels of Fink Racer. In the front straight Wyllie's Girl, Yogi Mac and Fink Racer bumped. Approaching the first turn Winklee Terror crossed to the rail, checking Fesco Man. On the first turn She's A Beauty checked off the heels of Yogi Mac and bumped with Fink Racer. On the second turn Winklee Terror and Trumpence bumped, checking Trumpence. On the third turn Fesco Man and Trumpence bumped. Trumpence underwent a post-race veterinary examination and no apparent injury could be detected. A post-race swab sample was taken from Fink Racer, winner of the event.

RACE 5 – LAUNCESTON VETERINARY HOSPITAL LAUNCESTON BREEDER – SE – 515 METRES

Elusive Olaf was slow out. Soon after the start Fesco Lass and Desert Racer bumped. In the front straight Desert Racer, Fesco Lass and Stylish April bumped, checking Fesco Lass, Kalaway Betty and Elusive Olaf. On the first turn Stylish April and Desert Racer bumped, checking Stylish April. In the home straight Desert Racer and One Arm Bandit bumped. One Arm Bandit tired in the home straight. A post-race swab sample was taken from Black Fesco, winner of the event.

RACE 6 – LAUNCESTON VETERINARY HOSPITAL LAUNCESTON BREEDER – SE – 515 METRES

Keep Ya Fresh, Superb Innings, Winkle Dutchy and St. Comet were slow out. In the front straight Winkle Dutchy and St. Comet bumped. Approaching the first turn Shaina Lass checked off the heels of Smooth Jinx. Shortly after, Gotta Be You crossed to the rail, checking Fesco Boy, Smooth Jinx and Shaina Lass. On the second turn Keep Ya Fresh and Smooth Jinx bumped, checking Smooth Jinx. In the back straight Shaina Lass checked off the heels of Smooth Jinx. A post-race swab sample was taken from Fesco Boy, winner of the event.

RUN ON: 6 5 7 2 3 1 9 10 MARGINS: $\frac{3}{4}$ x HD TIME: 30.27

RACE 7 – CROWN LAGER AUSTRALIA'S FINEST – INV – 515 METRES

The start of this race was delayed approximately seven minutes when the boxes failed to open on the first attempt. All greyhounds were removed from the starting boxes, examined by the veterinary surgeon and passed fit to race. Bongioletti, Misty Fiord and Kinloch's Fox were slow out. In the front straight Tah Stella and Bassett bumped. At the same time, Misty Fiord and Kinloch's Fox bumped. Approaching the first turn Misty Fiord and Kinloch's Fox bumped. On the second turn Bongioletti checked off the heels of Misty Fiord. In the back straight Tah Stella faltered and lost considerable ground. Approaching the finish, Kamikaze Turtle and Bassett bumped. Tah Stella underwent a post-race veterinary examination which revealed the greyhound to have a fractured right hock. Tah Stella has been stood down from racing for a period of five months at all tracks.

RACE 8 – GORACINGTASMANIA.COM.AU – MIXED4/5 – 515 METRES

The start of this race was delayed approximately three minutes due to the delay from race 7. Soon after the start Molly Supernova, Furious Floss, Queen Matilda and Buckle Up Labi bumped, checking Queen Matilda. In the front straight Buckle Up Labi checked off the heels of Molly Supernova, checking Furious Floss. Approaching the first turn Tom Tom Drum checked off the heels of Madam Mila, checking Buckle Up Labi and Queen Matilda. In the back straight Furious Floss, Madam Mila and Tom Tom Drum bumped, checking Madam Mila. On the home turn Furious Floss and Hat Trick Babe bumped. Entering the home straight Furious Floss checked off the heels of Molly Supernova. Approaching the finish, Queen Matilda checked off the heels of Madam Mila.

RUN ON: 4 6 7 5 1 8 3 2 MARGINS: $\frac{3}{4}$ x $1\frac{1}{4}$ TIME: 30.25

RACE 9 – FURNITURE CITY – GRADE 5(1) – 515 METRES

Rosie Oh Rosie was slow out. Soon after the start Nebraska Beach, Half Century and Gold Lenny bumped, checking Half Century. At the same time Kinloch Country and Shogun Steel bumped. In the front straight Hello Nancy crossed to the rail, checking Kinloch Country and Shogun Steel. Approaching the first turn Hello Nancy, Nebraska Beach, Gold Lenny and Ultimate Paddy bumped, checking Nebraska Beach and Ultimate Paddy. As a result, Shogun Steel checked off the heels of Ultimate Paddy, checking Kinloch Country and Rosie Oh Rosie. In the back straight Gold Lenny checked off the heels of Nebraska Beach. On the third turn Rosie Oh Rosie checked off the heels of Shogun Steel, checking Kinloch Country. On the home turn Gold Lenny, Half Century and Nebraska Beach bumped, checking Half Century.

RUN ON: 8 2 9 7 4 5 1 6 MARGINS: $\frac{1}{2}$ x $1\frac{1}{4}$ TIME: 30.35

RACE 10 – LUXBET BEST OF THE BEST – GRADE 5(2) – 515 METRES

Soon after the start Ramsey De Kahn, Frosty's Capable, Cooper's Shadow and Madam Anne bumped, checking Frosty's Capable. Shortly after, Madam Anne, Cooper's Shadow and Ramsey De Kahn bumped, checking Cooper's Shadow which bumped with Inanna Star. Approaching the first turn Ramsey De Kahn, Madam Anne and Runout Babe bumped, checking Madam Anne, resulting in Cooper's Shadow checking off the heels of Madam Anne, checking Oh So Nice and Inanna Star. On the first turn Cooper's Shadow checked off the heels of Runout Babe. On the second turn Frosty's Capable, Inanna Star and Oh So Nice bumped, checking Frosty's Capable.

GENERAL

Due to the starting boxes malfunctioning races 7 8 9 and 10 were hand started.

Gangalla Rebel completed a Stewards satisfactory trial as this greyhound had not raced for in excess of six months pursuant to LR31.3. Weighing 30.2kgs and beginning from box 3, Gangalla Rebel completed the 278 metres trial distance in a time of 16.35. Gangalla Rebel has been cleared to race at all tracks.
