Rohn underwent a post-race veterinary examination which revealed an injured second toe on the left front foot. Rohn has been stood down from racing for a period of 10 days.

Soon after, Touch Of Silk, Dangerous Liaison, Whip Carter, Platinum Judy, Family Pick and Buckle Up Tassie bumped, checking Whip Carter, Touch of Silk, Buckle Up Tassie, Dangerous Liaison and Platinum Judy. Jamella Red raced wide in the back straight. On the first turn Buckle Up Tassie and Touch Of Silk bumped, checking both greyhounds. Soon after, Bigtime To Excel and Family Pick bumped, checking both greyhounds. On the home turn Bigtime To Excel and Family Pick bumped. Entering the home straight Dangerous Liaison and Platinum Judy bumped. Approaching the winning post Bigtime To Excel and Platinum Judy bumped. Platinum Judy, Dangerous Liaison and Touch of Silk raced wide in the home straight.

Stewards spoke to trainer Mr David Polley in relation to the racing manners of Bigtime to Excel. In particular, the racing manners of the greyhound between the first turn and home turn. Mr Polley could offer no explanation only that the greyhounds muzzle had been damaged and that the greyhound may have caught its teeth in the muzzle. In viewing the official patrol films and from their own observations Mr Polley was advised that stewards would monitor the greyhound's future racing manners and no further action was taken.

Bigtime To Excel underwent a post-race veterinary examination and no apparent injury could be detected. Dangerous Liaison underwent a post-race veterinary examination and no apparent injury could be detected. A post-race swab sample was taken from Jamella Red, winner of the event.

On the first turn Tip It Up checked off the heels of Scruffy Squaw. On the home turn Tip It Up checked off the heels of Honcho Bound. As a result, Tip It Up and Bongioletti bumped, checking both greyhounds.

In the home straight Maggie Fitz and I'm Mad bumped. Maggie Fitz underwent a post-race veterinary examination which revealed soreness to the right hind gracilis muscle. Maggie Fitz has been stood down from racing for a period of 10 days. A post-race swab sample was taken from Country Greg, winner of the event.

GENERAL

Trainer Mr G Sherriff was reprimanded pursuant to GAR33(4) in that he presented Honcho Bound without the correct registration papers.

Enfield Ellen completed a Stewards satisfactory trial as it had been stood down from the North-West Greyhound Racing Club meeting on 10 December 2016 for failing to pursue the lure with due commitment throughout the event pursuant to GAR69B(1)(a). Weighing 27.2kgs and beginning from box 3, Enfield Ellen completed the 461 metre trial distance in a time of 26.44. Enfield Ellen has been cleared to race at all tracks.

Bunna Boy completed a satisfactory Stewards trial as it had not raced for a period of in excess of six months pursuant to LR31.3. Weighing 33.8kgs and beginning from box 3, Bunna Boy completed the 340 metre trial distance in a time of 19.85. Bunna Boy has been cleared to race at all tracks.

Hypatios completed a satisfactory Stewards trial as it had not raced for a period of in excess of six months pursuant to LR31.3. Weighing 33.6kgs and beginning from box 5, Hypatios completed the 461 metre trial distance in a time of 26.92. Hypatios has been cleared to race at all tracks.

Lyncar Suzie completed a Stewards satisfactory trial as it had been stood down from the Hobart Greyhound Racing Club meeting on 9 March 2017 for failing to pursue the lure with due commitment throughout the event by reason of injury pursuant to GAR69B(1)(a). Weighing 27.0kgs and beginning from box 5, Lyncar Suzie completed the 461 metre trial distance in a time of 26.95. Lyncar Suzie has been cleared to race at all tracks.

Vitor completed a satisfactory Stewards trial as it had not raced for a period of in excess of six months pursuant to LR31.3. Weighing 36.1kgs and beginning from box 3, Vitor completed the 340 metre trial distance in a time of 20.07. Vitor has been cleared to race at all tracks.
