RACE 1 – O’DRISCOLL COAHES EASTER PURSE HEAT 1 – GRADE 6 461M

Elusive Olaf was slow out. Soon after the start Willie Mac and Kalaway Champ bumped checking Kalaway Champ. On the first turn Kalaway Champ eased. Soon after Cawbourne Era checked off the heels of Sweet Abbella. Kalaway Champ underwent a post-race veterinary examination and no apparent injury could be detected. Stewards spoke to trainer Mr R Walker in relation to the racing manners of Kalaway Champ on the first turn. After taking evidence from Mr Walker, viewing the official race replays and acting on their own observations Stewards were of the opinion that Kalaway Champ had visibly eased when free of interference and in doing so had failed to pursue the lure with due commitment throughout the event. Acting under the provisions of GAR69A(1) Kalaway Champ has been stood down from racing for a period of 28 days at Hobart only and until the completion of a satisfactory trial.

RACE 2 – O’DRISCOLL COACHES EASTER PURSE HEAT 2 – GRADE 6 461M

Desert Racer, Metanoia Franco and Captain Red were slow out. In the back straight Keep Ya Vision and Kalaway Cobs bumped checking Keep Ya Vision. Soon after Keep Ya Vision and Reggie Hards bumped. On the first turn Keep Ya Vision and Reggie Hards bumped severely checking Keep Ya Vision. On the home turn Desert Racer and Lansley Angel bumped. Desert Racer underwent a post-race veterinary examination which revealed swelling to it’s right front leg and to it’s hind leg however no stand down period was applied.

Approaching the home turn She’s A Beauty checked off the heels of Keep Ya Fresh. New Tears Angel raced wide in the home straight. Approaching the winning post Wyllie’s Girland Keep Ya Fresh bumped.

Soon after the start Maharani and Thumb Print bumped. On the first turn Pickled Tink checked off the heels of Thumb Print. Approaching the winning post Ya Want Some checked off the heels of Keune. A Post-Race swab sample was taken from Gold Lenny the winner of the event.

Whistledown was slow out. On the first turn Celtic Kid and Whistledown checked off the heels of Bemboka Belle. Soon after Celtic Kid checked off the heels of Whistledown. Wynburn Alpha raced wide in the home straight.

RACE 6 – LUXBET EASTER CUP HEAT 2 – 1/2/3 461M

Soon after the start Justifia crossed to the rail checking Prescribe. In the back straight Halo Lee, Prescribe and Lashing Jackson bumped checking Lashing Jackson. Soon after Halo Lee crossed wide. On the first turn Justifia faulted checking Wynburn Tootie, Stylish Nic and Bunna Boy. Soon after Lashing Jackson and Justifia bumped checking Lashing Jackson. Halo Lee raced wide in the home straight. Justifia which trailed the field throughout the event and failed to finish underwent a post-race veterinary examination revealed a fractured right hock. Justifia has been stood down from racing for a period of 42 days.

In the back straight Oliver Queen and Marteeny bumped checking Oliver Queen. Soon after Oliver Queen and Marteeny bumped. Approaching the first turn Devil’s Gullet and Banquet bumped. On the first turn Majestic Tale checked off the heels of Buckle Up Beneau. Majestic Tale underwent a post-race veterinary examination and no apparent injury could be detected.

In the back straight Whodat Bangin’ and Black Chevelle bumped. Soon after Whodat Bangin’ and Dame Kirra bumped checking Dame Kirra. On the first turn Nekhbet and Black Chevelle bumped checking Nekhbet. Soon after Cosmicly Baroque checked off the heels of Nekhbet. Approaching the home turn Nekhbet checked off the heels of Black Chevelle. Cosmicly Baroque and Dame Kirra raced wide in the home straight.

RACE 9 – CARLTON DRAUGHT EASTER PLATE HEAT 4 – MIXED 4/5 461M

Bobby Bound was slow out. Soon after the start Ozzi Oscar and Family Challenge bumped. Family Challenge and Bel Air Mist bumped severely checking Bel Air Mist. On the first turn Free Spins checked off the heels of Country Helen. Ramsey De Khan checked off the heels of Family Challenge. Approaching the home turn Free Spins and Test Pilot bumped checking both greyhounds.

Lucky Linc was slow out. Soon after the start Grouse and High Treason bumped. On the first turn Grouse and High Treason bumped checking High Treason and Young Jake. Soon after Young Jake and Honcho Bound bumped checking both greyhounds. Approaching the home turn High Treason checked off the heels of Nine Squared.

General:

Rosie Oh Rosie completed a Stewards satisfactory trial as it was stood down from the LGRC meeting on the 27th March 2017 for marring pursuant to GAR69(1). Beginning from box 3 Rosie Oh Rosie completed the 461M trial distance in a time of 26.66. Due to its racing manners in the home straight Rosie Oh Rosie did not trial to the satisfaction of Stewards and therefore has not been cleared to race.

Baron Lad underwent a Stewards Trial pursuant to GAR74(3) as it suffers from a veterinary condition called pannus. Beginning from box 3 Baron Lad completed the 340M trial distance by finishing 4th in a time of 20.25 seconds. Baron Lad has not been cleared to race as it did not run the qualifying time.

Trainer E Medhurst was reprimanded under GAR48 for failing to provide a catcher for his greyhound engaged in race 7.
