Shaina Lass, Captain Red and New Tears Angel were slow out. Approaching the first turn Captain Red and Shaina Lass bumped checking both greyhounds. On the first turn Arnhem Invader, It's A Wink and Arnhem Mayhem bumped checking Arnhem Invader and Arnhem Mayhem. On the home turn Arnhem Mayhem, Arnhem Invader and captain Red bumped checking Arnhem Invader and Captain Red.

**RACE 2 – ORBIT LIGHTING SORELL ROC MIXED 4/5 340M**

Magpie Fencer and Lyncar Magic were slow out. Soon after the start Shanlyn Witch, Bemboka Belle, Centre Pine and Mewstone Rocket bumped checking Mewstone Rocket. On the first turn Wicked Turtle, Bemboka Belle and Magpie Fencer bumped checking all three greyhounds and as a result Lyncar Magic checked off the heels of Bemboka Belle and bumped with Mewstone Rocket. Approaching the home turn and rounding the home turn Lyncar Magic and Mewstone Rocket bumped on several occasions. In the home straight Centre Pine eased. Lyncar Magic and Mewstone Rocket raced wide in the home straight. Centre Pine underwent a post-race veterinary examination and no apparent injury could be detected. Stewards spoke to trainer Mr P Phillips in relation to the race manner of Centre Pine in the home straight. Acting on their own observations, viewing the official replays and after taking evidence from Mr Phillips Stewards were of the opinion that Centre Pine had eased free of interference in the home straight and in doing so failed to pursue the lure with due commitment throughout the event pursuant to GAR69(A)(1). Acting under the provisions of GAR 69(A)(2)(a) Centre Pine has been stood down from racing for a period of 28 days at Hobart and until the completion of a Satisfactory trial. Lyncar Magic underwent a post-race veterinary examination which revealed the greyhound to have soreness to the tensor fascia muscles. Lyncar Magic has been stood down from racing for a period of 5 days. Stewards spoke to trainer Mr L Nichols in relation to the race manner of Lyncar Magic rounding the home turn. Acting on their own observations, viewing the official replays and after taking evidence from Mr Nichols Stewards were of the opinion that Lyncar Magic and Mewstone Rocket bumped on a number of occasions resulting in both greyhounds becoming unbalanced and losing momentum. After taking that into account and also the injury to Lyncar Magic Stewards took no further action.

A Post-race swab sample was taken from Shanlyn Witch, the winner of the event.

At the same time Swift Mover and Burning House bumped. In the back straight Maharani, Next Matador and Hello Nancy bumped checking Hello Nancy. On the first turn Swift Mover and Burning House bumped checking Burning House and severely checking Swift Mover and checking Free Spins. As a result, Maharani checked off the heels of Burning House and Next Matador checked off the heels of Swift Mover. Entering the home straight Burning House galloped on the heels of Free Spins,

checking Free Spins. Approaching the finish Hello Nancy and Free Spins bumped. Whodat Bangin' raced wide in the home straight. Next Matador underwent a post-race veterinary examination and no apparent injury could be detected. Swift Mover underwent a post-race veterinary examination and no apparent injury could be detected. Free Spins underwent a post-race veterinary examination and no apparent injury could be detected. A post-race swab sample was taken from Spec Bennett the winner of the event.

On the first turn Lyncar Suzie and Diamond Image bumped checking Lyncar Suzie. Approaching the home turn Izzy A Prince checked off the heels of Regent Lois. Entering the home straight Diamond Image crossed wide off the heels of Izzy A Prince and bumped with Coolan Girl. In the home straight Coolan Girl checked off the heels of Diamond Image. Tigra Tron, Coolan Girl and Diamond Image raced wide in the home straight.

#### **General:**

Repayments completed a Stewards satisfactory trial. This greyhound had not raced for in excess of 6 months pursuant to LR31.3. Weighing 32.9kg and beginning from box 3 Repayments completed the 461M trial distance in a time of 26.54. Repayments has been cleared to race at all tracks.

Shogun Steel completed a Stewards satisfactory trial as it was stood down from racing from the NWGRC on the 11<sup>th</sup> of April 2017 for failing to pursue the lure with due commitment throughout the event pursuant to GAR 69(A)(1). Weighing 31.6kg and beginning from box 3 Shogun Steel completed the 461M trial distance in a time of 26.84. Shogun Steel has been cleared to race at all tracks except Devonport.

Rosie Oh Rosie completed a Stewards satisfactory trial as this greyhound was stood down from racing at the LGRC on the 27<sup>th</sup> of March 2017 for marring pursuant to GAR 69(1). Weighing 27.8kg and beginning from box 5 Rosie Oh Rosie completed the 461M trial distance in a time of 26.81. Rosie Oh Rosie has been cleared to race at all tracks except for Launceston.
