QUALIFYING TRIAL 1 – 461 METRES

Softie Sue and Bellewstown were slow to begin. Soon after the start Pepper Rock and Superior Jethro bumped. On the first turn Pepper Rock checked off the heels of Duck In Town. Approaching the home turn Superior Jethro and Aware bumped. Approaching the winning post, Swift Mover checked off the heels of Duck In Town. A Post-race swab samples were taken from Duck In Town, winner of the event. A post-race veterinary examination of Softie Sue revealed muscle soreness to its right hip. Softie Sue has been stood down from racing for a period of 5 days.
