Captain Red was slow to begin. In the back straight New Tears Angel checked off the heels of Diamond Lass. On the first turn Diamond Lass checked off the heels of Superb Innings. Soon after, Captain Red checked off the heels of Diamond Lass. At the same time Elusive Olaf galloped on the heels of Shaina Lass, checking both greyhounds.

GENERAL

Rockstar Eliza completed a Stewards satisfactory trial pursuant to LR31.3 and a weight trial pursuant to GAR40 as it had not raced for a period in excess of six months.
