Puddle Jumper underwent a post-race veterinary examination which revealed the greyhound to have bruising to the right hind thigh. Puddle Jumper has been stood down for a period of 3 days. A post-race swab sample was taken from Satin Style, the winner of the event.

Shortly after Buzzsaw, Adam's Spot, Dan Road and Diamond Lass bumped checking Diamond Lass, Dan Road and Adam's Spot. On the first turn Yes Messi and Buzzsaw bumped checking Buzzsaw. Approaching the home turn Adam's Spot checked off the heels of Buzzsaw. On the home turn Still Working and Yes Messi bumped. Buzzsaw underwent a post-race veterinary examination and no apparent injury could be detected.

#### **General:**

Can Bee completed a Stewards Satisfactory trial as this greyhound was stood down from the LGRC on the 8<sup>th</sup> of May 2017 for marring pursuant to GAR 69 (1) and also to seek approval to wear blinkers pursuant to GAR 36 (1). Weighing 29kg and starting from box 3, Can Bee completed the 452M trial distance in a time of 26.46 Can Bee has been cleared to race at all tracks except for LGRC. Can Bee has been cleared to race in an off side blinker.

Posh Pete completed a Stewards satisfactory trial to seek approval to wear blinkers pursuant to GAR 36 (1). Weighing 31.7 kg and beginning from box 5 Posh Pete completed the 452M trial distance in a time of 26.85. Posh Pete has been cleared to race at all tracks wearing an off side blinker.
