Wynburn Archer underwent a post-race veterinary examination and was found to have soreness to the front right wrist. Wynburn Archer was stood down from racing for a period of 6 days. Stewards spoke to trainer Mr B Deverell in relation to the racing manners of Wynburn Archer in the home straight and approaching the winning post. Acting on their own observations, reviewing the official replays and taking evidence from Mr Deverell. Stewards were of the opinion that Wynburn Archer had eased and in doing so had failed to pursue the lure with due commitment throughout the event pursuant to GAR 69A(1). Acting under the provisions of GAR 69A(2)(b) Wynburn Archer has been stood down from racing for a period of 28 days at LGRC track only and until the completion of the satisfactory trial. A post-race swab sample was taken from Chief Jetpilot, winner of the event.
