Weona Vee completed a Stewards satisfactory trial over the 461 trial distance after having been stood down at the HGRC meeting on the 16<sup>th</sup> of March 2017 pursuant to GAR 69(1)(a) for failing to pursue. Weighing 32.2kg and beginning from box 3, Weona Vee completed the

461M trial distance in a time of 26.78, finishing 2<sup>nd</sup> in the trial. Weona Vee has been cleared to race at all tracks.

Lisa Mae completed a Stewards satisfactory over the 340M trial distance pursuant to LR 31.3 as it had not started in an event for a period in excess of six months. Weighing 29.3kg and beginning from box 3 Lisa Mae completed the 340M trial distance in a time of 19.98. Lisa Mae has been cleared to race at all tracks.
