### RACE 1 – M/5/6 (1) – 461M

Lyncar Suzie and Nanna June were slow to begin. Soon after the start Assembly and Molly Supernova bumped, immediately after Suspect Nargles and Molly Supernova bumped checking both greyhounds. In the back straight Suspect Nargles and Assembly bumped. On the first turn Suspect Nargles and Assembly bumped checking Suspect Nargles. On the first turn Lyncar Suzie checked off the heels of Atomiser. Approaching the home turn Nanna June checked off the heels of Molly Supernova.

### RACE 2 – M/5/6 (2) – 461M

Soon after the start Wynburn Toro and Madam Mila bumped and Golden Nugget crossed to the rail checking Destini Tweed and severely checking Wynburn Toro which became unbalanced and as a result lost ground. In the back straight Windfast Duck checked off the heels of Wynburn Toro. Approaching the home turn Queen Miela and Golden Nugget bumped. On the home turn Windfast Duck checked off the heels of Tah Mcevoy. Approaching the winning post Queen Miela checked off the heels of Destini Tweed. Wynburn Toro underwent a post-race veterinary examination and no apparent injury could be detected. Stewards spoke to trainer Mrs M

Rossendell in relation to the interference suffered by Wynburn Toro in the back straight as a result of being severely checked and becoming unbalanced. Stewards were satisfied that this was the reason for the greyhound losing ground in the back straight and took no action against the greyhound. Mrs Rossendell also advised that she believed the greyhound had got its teeth caught in its muzzle as a result of the interference.

**RACE 3 – M/5/6 (3) – 461M**

In the back straight Take Time Tracy and Racy Gracie bumped. Approaching the first turn Racy Gracie eased close to the rail and lost ground. On the home turn Frecklenator and Platnium Cye bumped. Racy Gracie underwent a post-race veterinary examination which revealed a muscle injury to its left hind leg. Racy Gracie has been stood down from racing for a period of 7 days.
