### **RACE 1 – THE ADVOCATE – GRADE 6 – 452 METRES**

It's A Party, Spirited Diamond and Miss Morvill were slow out. Soon after the start Hogwash, Fernando Gold and Fernando Bolt bumped, checking Fernando Gold. On the first turn Keep Ya Vision, Miss Morvill and It's A Party bumped, checking Miss Morvill, It's A Party and Spirited Diamond. Shortly after, Keep Ya Vision, Hogwash and Fernando Gold bumped, checking Hogwash. In the home straight Silent Boloney checked off the heels of Fernando Bolt. A post-race swab sample was taken from Keep Ya Vision, winner of the event.

### **RACE 2 – SUREPICK – GRADE 5(1) – 452 METRES**

Yogo Xena was slow out. Soon after the start Capetown Jinx, Brusha Borne, Buckle Up Spud and Oliver Queen bumped, checking Brusha Borne. In the back straight Capetown Jinx and Buckle Up Spud bumped. On the first turn Buckle Up Spud checked off the heels of Capetown Jinx. On the home turn Oliver Queen and Ferrios bumped.

Soon after the start Moto Warrior, George's Lad and Baci De Kahn bumped, resulting in George's Lad checking off the heels of Moto Warrior. Shortly after King Pedro and Platinum Judy bumped. Approaching the first turn Platinum Judy, King Pedro and Diamond Image bumped, checking Platinum Judy. On the first turn Jinx checked off the heels of Diamond Image. Entering the home straight Diamond Image, King Pedro and George's Lad bumped. Moto Warrior, George's Lad and Platinum Judy raced wide in the home straight.

### **RACE 4 – SEBA SHEETMETAL – MIXED ½ - 452 METRES**

In the back straight Nebraska Beach crossed to the rail, checking Lyncar Jerry and Hello Diamond. Approaching the first turn Cosmic Heir crossed to the rail, checking Nine Squared. On the first turn Dilston Delight checked off the heels of Silver Drone. Approaching the home turn Hello Diamond checked off the heels of Nebraska Beach, checking Nine Squared and Silver Drone. Entering the home straight Silver Drone checked off the heels of Hello Diamond.

### **RACE 5 – PUT YOUR QUADDIES ON – GRADE 4(1) – 452 METRES**

Lyncar Teagan was a late scratching at 9.12am pursuant to GAR23(4) due to illness. Lyncar Teagan has been stood down from racing for a period of 10 days. Trainer Mrs C Nash was advised that she must submit a veterinary certificate confirming the illness within 48 hours to the Office of Racing Integrity, pursuant to LR25.6. Soon after the start Black Rhino, Finnigans Way and Adam's Bandit bumped. Approaching the first turn Adam's Bandit crossed to the rail, checking Black Rhino and Kiss Me Victor. In the home straight Droopy's Gem and Adam's Bandit bumped. Kiss Me Victor and Black Rhino raced wide in the home straight.

### **RACE 6 – DOWLING MCCARTHY TYRES – GRADE 5(3) – 452 METRES**

Quintessa was slow out. Soon after the start Tigra Tron checked off the heels of Can Bee. In the back straight Can Bee and Ramsey De Kahn bumped on several occasions, checking Ramsey De Kahn. Approaching the first turn Niko Tecoma checked off the heels of Tigra Tron. Entering the home straight Unshackled checked off the heels of Can Bee. Cawbourne Drive, Unshackled and Tigra Tron raced wide in the home straight. Can Bee underwent a post-race veterinary examination which revealed the greyhound to have a corn on the inside of the right fore toe however no stand down period was applied. Stewards spoke to trainer Mr A Clark in relation to the race manners of Can Bee in the home straight. Acting on their own observations, viewing the official race replays and taking evidence from Mr Clark, Stewards had concerns with the race manner of Can Bee and, in particular, when drifting up the track in the home straight, however, were not satisfied that the greyhound had failed to pursue the lure with due commitment and took no further action. A post-race swab sample was taken from Can Bee, winner of the event.

### **RACE 7 – CARLTON DRAUGHT – GRADE 3 – 452 METRES**

He's A Boomer was slow out. In the back straight Tax Man Wins crossed to the rail, checking Dilston Loch which then crossed wide, checking Mahalo Man. Shortly after, Buckle Up Beneau and Dolly Dyer bumped on several occasions. On the first turn Mahalo Man checked off the heels of Buckle Up Labi. Approaching the home turn Buckle Up Beneau and Dolly Dyer bumped, checking Dolly Dyer. Entering the home straight Dilston Loch and Dolly Dyer bumped. Buckle Up Beneau underwent a post-race veterinary examination which revealed the greyhound to have spike wounds to the right hind leg. Buckle Up Beneau has been stood down from racing for a period of 5 days.

### **RACE 8 – SIMON'S DESIGN CENTRE – GRADE 5(4) – 452 METRES**

Soon after the start Buzzsaw and Cawbourne Lilly bumped. At the same time Whoop Bang and Adam's Spot bumped. Shortly after, Buzzsaw, Cawbourne Lilly, Adam's Spot and Whoop Bang bumped, checking Cawbourne Lilly and Whoop Bang. Approaching the first turn Frazzle Dazzle, Buckle Up Jones and Buzzsaw bumped. At the same time, Whoop Bang galloped on the heels of Leica Warrior, checking both greyhounds. Shortly after, Frazzle Dazzle, Buckle Up Jones, Buzzsaw and Mac The Knife bumped, severely checking Frazzle Dazzle which fell, checking Buckle Up Jones, Leica Warrior, Cawbourne Lilly, Buzzsaw and Whoop Bang. On the first turn Buzzsaw checked off the heels of Leica Warrior. Entering the home straight Mac The Knife galloped on the heels of Adam's Spot, checking Adam's Spot. Frazzle Dazzle underwent a post-race veterinary examination which revealed the greyhound to have a small spike wound to the top of the right hind foot however no stand down period was applied. Adam's Spot underwent a post-race veterinary examination which revealed minor abrasions to the right hind leg however no stand down period was applied. A post-race swab sample was taken from Mac The Knife, the winner of the event.

### **RACE 9 – SYNECTIC DEVONPORT – GRADE 4(2) – 452 METRES**

Soon after the start Droopy's Ella, Halo Henry, Bassett and Winklea Faith bumped, checking Halo Henry and Bassett. At the same time Chloe Mac, Devil's Gullet and Kamikaze Turtle bumped, checking Kamikaze Turtle which faltered and then tailed the field for the remainder on the event. Approaching the first turn Bassett galloped on the heels of Halo Henry, checking both greyhounds. On the first turn Winklea Faith crossed wide, checking Droopy's Ella. As a result, Winklea Faith galloped on the heels of Chloe Mac, checking both greyhounds. In the home straight Halo Henry and Winklea Faith bumped, checking Winklea Faith. Kamikaze Turtle underwent a post-race veterinary examination which revealed the greyhound to have soreness to the right hock. Kamikaze Turtle has been stood down from racing for a period of 10 days.

### **RACE 10 – LUXBET – GRADE 5(5) – 452 METRES**

Faboom and Ricson Flyer were slow out. Soon after the start Faboom and Ricson Flyer bumped. In the back straight Winklee Colin and Tah Jen bumped. On the first turn Take The Crown checked off the heels of Ricson Flyer. Approaching the home turn Take The Crown, Faboom and Winklee Colin bumped, checking Faboom.

### **General**

Wynburn Archer completed a Stewards satisfactory trial as this greyhound was stood down from the LGRC meeting 29 May 2107 for failing to pursue the lure with due commitment throughout the event pursuant to GAR 69A(1). Weighing 31.5kg and beginning from box 5, Wynburn Archer completed the 452 metre trial distance in a time of 25.47. Wynburn Archer has been cleared to race at all tracks except Launceston.

Shogun Steel completed a Stewards satisfactory trial as this greyhound was stood down from the NWGRC meeting 11 April 2107 for failing to pursue the lure with due commitment throughout the event pursuant to GAR 69A(1). Weighing 31.8kg and beginning from box 3, Shogun Steel completed the 452 metre trial distance in a time of 26.45. Shogun Steel has been cleared to race at all tracks.
