RACE 1 – A TOTAL CAR RENTALS – GRADE 5 (1) 515M

Stefan's Choice was slow out. In the front straight Freehold, King Pedro and Spring Gully Jet bumped checking King Pedro. Approaching the first turn Freehold, Ambivalence and Stefan's Choice bumped checking Ambivalence. Shortly after King Pedro, Freehold and Stefan's Choice bumped checking Freehold and Stefan's Choice. On the second turn Freehold and Stefan's Choice bumped. At the same time King Pedro checked off the heels of Spring Gully Jet. Entering the back straight Trumpece and Madam Mila bumped checking both greyhounds. Approaching the third turn Spring Gully Jet contacted the rail. Shortly after Spring Gully Jet and Freehold bumped, checking both greyhounds. As a result, Ambivalence checked off the heels of Spring Gully Jet. On the home turn Stefan's Choice checked off the heels of Freehold. Spring Gully Jet underwent a post-race veterinary examination, no apparent injury could be detected.

RACE 2 – KINGSLEY JARMAN FENCING – MASTERS – 278M

Rock On Rolla and Lucky Nineteen were slow out. Soon after the start Drum Grohl, Marley Rose and Adam's Jimmy bumped, checking Marley Rose which bumped with Rock On Rolla. Approaching the first turn Posh Faith crossed to the rail checking Adam's Jimmy which then stumbled checking Marley Rose. On the first turn Drum Grohl checked off the heels of Felicity Smoak. Entering the home straight Rock On Rolla checked off the heels of Bearville Azza. In the home straight Rock On Rolla galloped on the heels of Bearville Azza. Adam's Jimmy underwent a post-race veterinary examination and no apparent injury could be detected. A post-race swab sample was taken from Posh Faith the winner of the event.

RACE 3 – FURNITURE CITY – GRADE 4 – 278M

Magic Moz and Lucky Linc were slow out. Approaching the first turn Drury Lane checked off the heels of Voodoo Dream checking Parma Chief and severely checking Golden Nugget. Drury Lane underwent a post-race veterinary examination; no apparent injury could be detected. Golden Nugget underwent a post-race veterinary examination, revealed abrasions to the left fore and hind legs, however no stand down period was applied.

RACE 4 – GOLD STAR MUZZLES – GRADE 5 (2) 515M

Soon after the start Atomiser checked off the heels of Nellie Vee. Approaching the first turn Poppy's Ollie, Tom Tom Drum and Nellie Vee bumped, checking Tom Tom Drum. Nellie Vee, Izzy A Prince and Atomiser. In the back straight Izzy A Prince checked off the heels of Atomiser. On the home turn Nellie Vee and Tom Tom Drum bumped. Run Jackie Run tired in the home straight. In the home straight Poppy's Ollie marred the running of Run Jackie Run resulting in Shogun Steel checking off the heels of Run Jackie Run. Izzy A Prince underwent a post-race veterinary examination and no apparent injury could be detected. Poppy's Ollie underwent a post-race veterinary examination and no apparent injury could be detected. Stewards spoke to trainer Mr P Hall in relation to the race manner of Poppy's Ollie in the home straight. Acting on their own observations viewing the official replay and taking evidence from Mr Hall, Stewards were of the opinion that Poppy's Ollie had turned its head outwards and made head and muzzle contact with Run Jackie Run approaching the finish and in doing so marred the running of that greyhound pursuant to GAR 69 (1). Acting under the provisions of GAR 69 (2) (a) Poppy's Ollie has been stood down from racing for a period of 28 days at Launceston and until the completion of a satisfactory trial. Run Jackie Run underwent a post-race veterinary examination and no apparent injury could be detected.

RACE 5 – LUXBET DISTANCE CHAMPIONSHIP HEAT 1 – 720M

Soon after the start Bomber Dyson crossed to the rail checking Brusha Borne, Frosty's Capable, Lashing Jackson and Lady Rappa. On the second turn Bomber Dyson and Tee Cee Benny bumped, checking Tee Cee Benny. As a result, Lashing Jackson checked off the heels Tee Cee Benny checking Bit Hot Rusty. In the front straight Vronitos crossed to the rail checking Bomber Dyson and Tee Cee Benny. On the fifth turn Frosty's Capable checked off the heels of Tee Cee Benny. In the home straight Frosty's Capable checked off the heels of Bomber Dyson. Brusha Borne underwent a post-race veterinary examination and no apparent injury could be detected. Bity Hot Rusty underwent a post-race veterinary examination and no apparent injury could be detected. A post-race swab sample was taken from Frosty's Capable, the joint winner of the event.

RUN ON: 3 & 8DH 5 4 9 1 6 7 MARGINS: Dead Heat x 3 $\frac{3}{4}$ TIME: 43.05

RACE 6 – LUXBET DISTANCE CHAMPIONSHIP HEAT 2 – 720M

Soon after the start Buckle Up Jones, Double Dose, Mahalo Miss and Furious Floss bumped, checking Mahalo Miss and Happy Jeff. Approaching the first turn Buckle Up Jones, Double Dose and Furious Floss bumped checking Furious Floss. On the first turn Happy Jeff checked off the heels of Mahalo Miss. On the fourth turn Mahalo Miss checked off the heels of Double Dose. Entering the home straight Inanna Star, Buckle Up Jones and Le Baz bumped. In the home straight Furious Floss, Double Dose and Le Baz bumped resulting in Le Baz galloping on the heels of Furious Floss checking both greyhounds. A post-race swab sample was taken from Mahalo Miss, the winner of the event.

RACE 7 – SIMONS CARPET ONE – GRADE 4- 515M

Soon after the start Bassett and Prodigal Son bumped. Shortly after Devil's Gullet and Young Jake bumped checking Devil's Gullet. Approaching the first turn Young Jake, Devil's Gullet, Prodigal Son and Bassett bumped checking all four greyhounds, as a result Devil's Gullet bumped with Coffee Elizabeth. On the home turn Devil's Gullet checked off the heels of Young Jake. Coffee Elizabeth and Devil's Gullet raced wide in the back straight and the home straight.

RUN ON: 2 3 1 7 5 6 8 MARGINS: 3 $\frac{1}{4}$ x 1 $\frac{1}{4}$ TIME: 29.92

RACE 8 – WINNING EDGE KIBBLE – GRADE 5 (3) – 515M

Soon after the start Dylan Keeping, George's Lad, Redhead Relton and Tah Jen bumped, checking George's Lad and Redhead Relton. Approaching the first turn Dylan Keeping crossed to the rail checking Harry Steiger and Dame Kirra. At the same time Adam's Spot and Gatwick bumped. On the first turn Tah Jen and Redhead Relton bumped, as a result George's Lad checked off the heels of Redhead Relton. On the third turn Harry Steiger checked off the heels of Tah Jen checking Dame Kirra, Redhead Relton and George's Lad.

RUN ON: 5 3 8 1 10 2 6 7 MARGINS: $\frac{3}{4}$ x $\frac{1}{2}$ TIME: 30.38

RACE 9 – CARLTON DRAUGHT – BREWERY FRESH – GRADE 5 (4) 515M

Miss Montez and Adam's Lilly was slow out. On the second turn Miss Montez and Adam's Lilly bumped checking Adam's Lilly. Entering the back straight Ultimate Paddy checked off the heels of Sisco Rascal. On the third turn Aware, Sisco Rascal and Ultimate Paddy bumped, as a result Miss Montez checked off the heels of Ultimate Paddy checking Remember Jess and Tip It Up. On the home turn Hello Birdy checked off the heels of Ultimate Paddy checking Remember Jess. Entering the home straight Miss Montez and Ultimate Paddy bumped checking Miss Montez. Adam's Lilly underwent a post-race veterinary examination after collapsing in the catching pen. The veterinary surgeon subsequently reported the greyhound to be deceased. A post race swab sample was taken from Adam's Lilly. Stewards directed that an autopsy be conducted on Adam's Lilly to determine the cause of death. When questioned Trainer Mr B Adams stated that Adam's Lilly had shown no signs of any illness or problems and that she had been trialling well.

RACE 10 – LUXBET RACING CENTRE – GRADE 5 (5) – 515M

Call me Charlie, Carrick Marlow and Fancy Moss were slow out. Approaching the first turn Faboom, Flyin' Fez and Cool Dude Luke bumped, checking Cool Dude Luke. Shortly after Evanta Nemo, Carrick Marlow and Cool Dude Luke bumped, checking Carrick Marlow, Cool Dude Luke and Fancy Moss. Approaching the third turn Evanta Nemo and Flyin' Fez bumped, checking Flyin' Fez and Cool Dude Luke.

RUN ON: 1 3 6 2 5 7 8 4 MARGINS: 6 $\frac{1}{4}$ x $\frac{3}{4}$ TIME: 29.93

GENERAL

Can Bee completed a Stewards satisfactory trial as this greyhound was stood down from racing at the Launceston Greyhound Racing Club on the 8 May 2017 for marring pursuant GAR 69 (1). Weighing 28.8 kilos and beginning from box 3 Can Bee completed the 515m trial distance in a time of 29.78. Can Bee has been cleared to race at all tracks.

Runout Babe completed a Stewards satisfactory trial as this greyhound was stood down from the Launceston Greyhound Racing Club on the 5 June 2017 for failing to pursue the lure with due commitment throughout the event by reason of injury pursuant to GAR 69 B (1). Weighing 30.7 kilos and beginning from box 5 Runout Babe completed the 515m trial distance in a time of 30.47. Runout Babe has been cleared to race at all tracks.

Cold Tattoo completed a Stewards satisfactory trial as this greyhound was stood down from racing at the Launceston Greyhound Racing Club on 10 March 2017 for failing to pursue the lure with due commitment throughout the event, pursuant to GAR 69 A (1). Weighing 26.6 kilos and beginning from box 3, Cold Tattoo completed the 278m trial distance in a time of 16.36. Cold Tattoo has been cleared to race at all tracks, of a distance no greater 278m.

One Arm Bandit completed a Stewards satisfactory trial as this greyhound was stood down from the Launceston Greyhound Racing Club on the 15 May 2017 for failing to pursue the lure with due commitment throughout the event, pursuant to GAR 69 A (1). Weighing 31.5 kilos and beginning from box 5, One Arm Bandit completed the 278m trial distance in a time of 16.14. One Arm Bandit has been cleared to race at all tracks.
