**RACE 1 – M/5/6 – 452M**

Ted Mustang, Outa Manila and Rapid Surprize were slow out. In the back straight Suspect Nargles, Lancie Boy and Rapid Surprize bumped checking Rapid Surprize. On the first turn Rapid Surprize checked off the heels of Suspect Nargles. Approaching the home turn Ted Mustang and Suspect Nargles bumped resulting in Suspect Nargles checking off the heels of Rapid Surprize and shortly after Ted Mustang faltered. On the home turn Wicked Turtle checked off the heels of Lancie Boy checking Rapid Surprize. In the home straight Rapid Surprize checked off the heels of Wicked Turtle. Wicked Turtle, Suspect Nargles and Rapid Surprize raced wide in the home straight. Ted Mustang underwent a post-race veterinary examination which revealed the greyhound to have a fractured left hock. Ted Mustang was subsequently euthanised. Shogun Steel underwent a post-race veterinary examination and no apparent injury could be detected. Stewards spoke to trainer Mr A Bullock in relation to the race manner of Shogun Steel rounding the first turn. Acting on their own observations, viewing the official replays and taking evidence from Mr Bullock Stewards were of the opinion that Shogun Steel eased free of interference and in doing so failed to pursue the lure with due commitment throughout the event pursuant to GAR69A(1). Acting under the provisions of GAR 69A(2)(b) as this was the greyhounds second offence Shogun Steel has been stood down from racing for a period of 3 months at all tracks.
