Approaching the first turn Redhead Relton and Thumb Print bumped checking Redhead Relton. Soon after Family Pick stumbled. Approaching the home turn Redhead Relton checked off the heels of Thumb Print.

In the back straight Pepper Rock and Happy Hippy bumped. Approaching the first turn Pepper Rock and Happy Hippy bumped on several occasions. Approaching the home turn Happy Hippy checked off the heels of Pepper Rock. Assembly and Young Jake raced wide in the home straight. Happy Hippy underwent a post-race veterinary examination and no apparent injury could be detected.

Soon after Jamella Red and El Grand Richo bumped checking Tikiwi. On the first turn Hughey Dee and Sweet Abbella bumped checking both greyhounds. Approaching the home turn Hughey Dee and El Grand Richo bumped. Jamella Red, Tikiwi and Sweet Abella raced wide in the home straight.

RACE 4 – JG(4) – 641M

Midnight Giggles was slow out. Soon after the start Buckle Up Tilda and Bounding Boomer bumped. Soon after Regent Assassin, Windfast Duck and Bounding Boomer bumped checking Windfast Duck. Approaching the first turn Tactical Emperor and Bounding Boomer bumped. Tactical Emperor eased in the home straight approaching the winning post and lost ground. Tactical Emperor underwent a post-race veterinary examination which revealed the greyhound to have muscle soreness to its off side hind leg quadriceps muscle. Tactical Emperor has been stood down from racing for a period of 14 days. Stewards spoke to trainer Mr John Wilton in relation to the racing manners of Tactical Emperor over the concluding stages of the event. Acting under their own observations, viewing the official replays and after taking evidence from Mr Wilton Stewards were of the opinion that Tactical Emperor had fail to pursue the lure with due commitment throughout the event by reason of injury. Acting under the provisions of GAR 69B(1)(a) Tactical Emperor has been stood down from racing until the completion of a satisfactory trial.
