**RACE 1 – CARLTON DRAUGHT – AUSTRALIA’S BEST – GRADE 5(1) – 452M**

Soon after the start Immorta and Lord Dominator bumped. Soon after Azurium checked off the heels of Mewstone Rocket. In the back straight Immorta and Lord Dominator bumped on several occasions. Kao De Kahn raced wide in the back straight. Approaching the first turn Azurium galloped on the heels of Queen Malika, checking Queen Malika. Approaching the home turn Immorta checked off the heels of Lord Dominator and as a result, Mewstone Rocket checked off the heels of Immorta. Immorta underwent a post-race veterinary examination and no apparent injury could be detected. Stewards spoke to trainer Mr E Cripps in relation to Immorta’s racing manners, in particular in the home straight. Acting on their own observations, viewing the official replays and taking evidence from Mr Cripps, Stewards were of the opinion that Immorta had turned its head inwards and had made head and muzzle contact with Lord Dominator on at least two occasions, and by doing so had marred the running of that greyhound pursuant to GAR 69(1). Acting under the provisions of GAR 69(2)(a), Immorta, has been stood down from racing for a period of 28 days at Devonport only and until the completion of a satisfactory trial.

**RACE 2 – DOWLING MCCARTHY TYRES – GRADE 5(2) – 452M**

Lady Petronella was slow out. Soon after the start Shanlyn China and Rich Marlow bumped. Soon after Rikitikitana and Zoprush bumped. In the back straight Shanlyn China and Rikitikitana bumped. Approaching the first turn, Buckle Up Spud, Rich Marlo, Rikitikitana and Zoprush bumped, checking Zoprush, Rikitikitana, Shanlyn China, Buckle Up Spud and Rich Marlow. Approaching the home turn Rikitikitana and Lady Petronella bumped. Brusha Bourne raced wide rounding the home turn. Approaching the winning post Shanlyn China and Zoprush bumped. Zoprush underwent a post-race veterinary examination which revealed the greyhound to have swelling and bruising to the left whip muscle. Zoprush has been stood down from racing for a period of 10 days. Stewards spoke to trainer representative Mr Ian Thomas in relation to the racing manners of Zoprush in the home straight. Acting on their own observations, viewing the official replays and taking evidence from Mr Thomas Stewards were of the opinion that Zoprush had turned its head inwards, Stewards were unable to establish if the greyhound had made contact. However, in doing so Zoprush had failed to pursue the lure with due commitment throughout the event by reason of injury, pursuant to GAR 69B(1)(a). Zoprush has been stood down from racing until the completion of a satisfactory trial. A post-race swab sample was taken from Buckle Up Spud, winner of the event.

In the back straight Black Rhino and Evanta Nemo bumped, checking Black Rhino. Approaching the home turn Mac The Knife and Dolly Dyer bumped. Approaching the winning post Black Rhino checked off the heels of Glenrea Target.

Approaching the winning post Whip Carter crossed to the rails, checking Goodison Girl, which made contact with the rail. Goodison Girl underwent a post-race veterinary examination and no apparent injury could be detected. Major Audacious underwent a post-race veterinary examination and no apparent injury could be detected.
