RACE 1 – MEMBERSHIPS NOW DUE – GRADE 6 – 452M

Tah Bob was declared a late scratching at 11.22am when the greyhound was found to be overweight. Tah Bob has been stood down from racing for a period of 10 days and trainer Mr Anthony Bullock was fined the sum of \$50.00 pursuant to GAR 39(3).

Wynburn Lucifer was a late scratching at 10.51am pursuant to GAR 37(2) after a pre-weigh in examination by the on course veterinary surgeon revealed the greyhound to have diarrhoea. Wynburn Lucifer has been stood down from racing for a period of 6 days.

Approaching the first turn Winklee Terror crossed to the rails and as a result Taloumbi Drive checked off its heels. Soon after Wynburn Mustang checked off the heels of Taloumbi Drive. On the home turn Tah Penny and Wynburn Mustang bumped. As a result Wynburn Mustang and Winklee Terror bumped. In the home straight Wynburn Mustang checked off the heels of Winklee Terror. A post-race swab sample was taken from Like 'Em All, the winner of the event.

Cawbourne Dawnie was a late scratching at 10.31am by reason of illness pursuant to GAR 23(4). Cawbourne Dawnie has been stood down from racing for a period of 10 days. Trainer Mr Gary Johnson was informed that he must submit a veterinary certificate confirming the illness within 48hrs to the Office of Racing Integrity, pursuant to LR 25.6.

Lady Petronella was slow out. Soon after the start Viking Vixen and Spring Gully Jet bumped, soon after Mon Manny Red checked off the heels of Viking Vixen. On the first turn Mon Manny Red checked off the heels of Lady Petronella. Approaching the home turn Viking Vixen and Mon Manny Red bumped. In the home straight Viking Vixen and Mon Manny Red bumped on several occasions. Viking Vixen underwent a post-race veterinary examination and was found to have an injury to its right hind leg. Viking Vixen has been stood down from racing for a period of 4 days. Stewards spoke to trainer representative Mrs Robyn Johnson in relation to the racing manners of Viking Vixen on the first turn and in the home straight. Acting on their own observations, viewing the official replays and taking evidence from Mrs Johnson, Stewards were of the opinion that Viking Vixen had turned its head outwards and had made head and muzzle contact with Mon Manny Red in the home straight and by doing so had marred the running of that greyhound on at least two occasions, pursuant to GAR 69(1). Acting under the provisions of GAR 69(2)(a) Viking Vixen has been stood down from racing for a period of 28 days at Devonport only and until the completion of a satisfactory trial.

In particular after shifting out in the home straight Wynburn Archer changed strides on several occasions. After reviewing the official replays and taking evidence from Mr Deverell no action was taken against the greyhound. Stewards advised Mr Deverell that they would continue to monitor the racing manners of Wynburn Archer in future events. A post-race swab sample was taken from Zipping Billy, the winner of the event.
