RACE 1 – MEMBERSHIPS NOW DUE – GRADE 6(1) – 452M

Posh Pete was slow out. Soon after the start Winklee Jane and Circumspect bumped. In the back straight Beaver Creek checked off the heels of Tah Sadie. At the same time Posh Miranda crossed toward the rail checking Winklee Jane and Circumspect. Approaching the first turn Circumspect checked off the heels of Tah Sadie, severely checking Winklee Jane and Posh Miranda and checking Posh Pete. Posh Miranda underwent a post-race veterinary examination which revealed the greyhound to have spike wounds to the right fore leg and paw, however no stand down period was applied.

RACE 2 – DOWLING MCCARTHY TYRES – GRADE 6(2) – 452M

Tah Bandit was a late scratching at 11.36am by reason of a weight variation, pursuant to GAR 39(3) after the greyhound weighed in excess of 1kg over its last start. Tah Bandit has been stood down from racing for a period of 10 days. Trainer Mr M Bullock was subsequently fined the sum of \$100 as this was his second offence within three months. Soon after the start Posh Teagan and Girt By Sea bumped, at the same time Winklee Dutchy and Apocryphal bumped. Approaching the first turn Posh Teagan and Apocryphal bumped. On the first turn Apocryphal and Posh Teagan bumped severely checking Posh Teagan, which contacted the rail. At the same time Girt By Sea galloped on the heels of Tah Penny, checking both greyhounds. Entering the home straight, Apocryphal galloped on the heels of Tah Penny, checking Tah Penny. Posh Teagan underwent a post-race veterinary examination which revealed the greyhound to have muscle soreness to the left calf. Posh Teagan has been stood down from racing for a period of 5 days. Tah Penny underwent a post-race veterinary examination which revealed the greyhound to have a spike wound to the left fore paw, however no stand down period was applied.

Frosty's Capable was slow out. Soon after the start Hat Trick Babe, Happy Jeff and Take The Crown bumped, checking Happy Jeff which bumped with Frosty's Capable. Shortly after Parma Chief crossed toward the rail checking, Take The Crown, Hat Trick Babe and Kamikaze Turtle. As a result, Happy Jeff checked off the heels of Take The Crown, checking Frosty's Capable. Approaching the home turn, Fancy Moss checked off the heels of Take The Crown. Entering the home straight Happy Jeff checked off the heels of Regent Assassin. Regent Assassin underwent a post-race veterinary examination and no apparent injury could be detected.

RACE 4 – THE ADVOCATE – GRADE 4(1) – 452M

Lyncar Teagan was slow out. On the first turn Satin Style checked off the heels of Frazzle Dazzle.

RACE 5 – RAPIDVITE.COM – GRADE 5(1) – 452M

Sisco Rocco was slow out. Soon after the start, Whip Carter Nitro Grace and Zoprush bumped, checking Nitro Grace. In the back straight Whip Carter and Zoprush bumped. On the first turn Sisco Rocco checked off the heels of Zoprush. Shortly after Diamond Lass, Tah Jen and Zoprush bumped, checking Tah Jen. Approaching the home turn Sisco Rocco checked off the heels of Zoprush. In the home straight Nitro Grace checked off the heels of Whip Carter. A post-race swab sample was taken from Dylan Keeping, the winner of the event.

RACE 6 – CARLTON DRAUGHT – AUSTRALIA'S EST – GRADE 5(2) – 452M

Soon after the start Still Working and Broadcast Ted bumped. At the same time Runout Babe crossed toward the rail, checking Superb Innings and bumping with Outa Manila and Keep Ya Vision. In the back straight Runout Babe, Outa Manila and Keep Ya Vision bumped. Approaching the first turn, Runout Babe, Outa Manila and Keep Ya Vision bumped, checking, Outa Manila and Runout Babe. On the first turn Out Manila galloped on the heels of Still Working, checking Still Working. Runout Babe underwent a post-race veterinary examination which revealed the greyhound to have a tear to the right quadriceps. Runout Babe has been stood down from racing for a period of 14 days.

RACE 7 – WILLIAM STREET MEATS – INV 452M

Soon after the start Droopy's Jacket crossed toward the rail checking Mister Campo, Nebraska Beach and Wynburn Archer, which bumped with Black Chevell. Shortly after, Nebraska Beach checked off the heels of Droopy's Jacket. In the back straight Wynburn Archer checked off the heels of Nebraska Beach. On the first turn Nebraska Beach checked off the heels of Droopy's Jacket. Wynburn Archer underwent a post-race veterinary examination and no apparent injury could be detected. A post-race swab sample was taken from Black Chevelle, the winner of the event.

RUN ON: 3 8 1 2 7 5 4 6 MARGINS: ¾ x 1 ½ TIME: 26.02

RACE 8 – SYNTECTIC DEVONPORT – GRADE 5(3) – 452M

Vrontios was slow out. Soon after the start Mars Rising checked off the heels of Firing Point and bumped with Capetwon Jinx. Approaching the first turn Firing Point checked off the heels of Hogwash and bumped with Aware

and Golden Ticket. As a result, Mars Rising checked off the heels of Firing Point. On the first turn Vrontios, Mars Rising and Firing Point bumped, checking Vrontios and Firing Point. Approaching the home turn Vrontios and Firing Point bumped, checking both greyhounds. Firing Point underwent a post-race veterinary examination which revealed the greyhound to have bruising to the right calf muscle. Firing Point has been stood down from racing for a period of 5 days.

RACE 9 – SIMONS DESIGN CENTRE – GRADE 4(2) – 452M

Demon Lad was slow out. Soon after the start, Droopy's Ella and Real Stylist bumped. In the back straight Trumpence, It's A Wink and Droopy's Ella bumped. On the first turn, Droopy's Ella checked off the heels of It's A Wink, checking Real Stylist.
