### **RACE 1 –STEVES LIQUOR CLASS 3 HCP– 1200 METRES**

**Nunivak** – Shifted in under pressure approaching the 100 metres.

**Flash Missile** – Raced wide in the middle stages

**Seajamm** – Racing keenly. Steadied near the 900 metres.

**Calavera** – Had a tendency to lay in at approximately the 800 metres.

**Lonhwan** – Jumped awkwardly and slow into stride. Raced wide in the middle stages.

**Mon Londo** – Race keenly at approximately the 700 metres and as a result had to be restrained off the heels of other runners.

**Crystal Flame** – Steadied at approximately the 1000 metres.

#### **General:**

Stewards inquired into the reason for Crystal Flame (S. Barr) steadying near the 1000 metres. On inquiry, it was established that near the 1000 metres Charlemagne's Girl (I Toker) had shifted in slightly causing Crystal Flame to steady. Jockey Ismail Toker (Charlemagne's Girl) was warned and advised in future he is to make sure every effort to keep his mount straight.

Jockey Daniel Ganderton was fined the sum of \$50 under AR 91 for arriving late on course.

Trainer Ms Imogen Miller was fined the sum of \$50 under LR 13.3 for the late notification of a rider on Qui Samer.

Routine samples were ordered to be taken from the winner Fragment.

### **RACE 2 — CARLTON DRAUGHT MAIDEN - 1200 METRES**

**Little Pumba** – Carried outwards at approximately the 750 metres. Raced greenly throughout.

**Seabring Star** – Slow into stride (2L).

**Anastasia** – 700 metres shifted outwards near the 700 metres.

**Miss Brightside** – Bumped on jumping

**Fontein Harry** – Shifted out on jumping, making contact with another runner. Held up and shifted out under pressure in the home straight.

**J'nine's Delight** – Over raced in the middle stages.

### **RACE 3 — BROOKLYN PARK CLASS 1 C&G HCP - 1400 METRES**

**Newts** – Over raced in the early and middle stages of the event.

**Island Pirate** – Over raced in the early and middle stages of the event. Raced greenly and approaching the 800 metres threw its head in the air on a number of occasions and shifted out abruptly.

**Geegee Blackprince** – Underwent a pre-race veterinary examination after floating mishap in the float en route to course. The colt was found to have minor abrasions to right hip and head and was subsequently passed fit by Official Veterinary Officer to take its place in the field. When questioned regarding disappointing performance Jockey T Baker explained that the colt never felt comfortable in running and in his opinion the floating mishap may have contributed to disappointing performance.

Routine samples were ordered to be taken from the winner Mr America.

### **RACE 4 —TRADIES & LADIES 18<sup>TH</sup> OCTOBER MAIDEN - 1400 METRES**

**Shivida** – Raced without cover for the majority of the race.

**Teddy's Fault** – Approaching the 400 metres was held up for a clear run.

**Kasuku** – Warning issued for being fractious in the barriers.

**Snippety Cat** – Warning issued for being difficult to load.

**Araya Hope** – Underwent a post-race veterinary examination and was found to be lame in the right hind. A veterinary certificate of soundness will be required prior to its next race start.

Routine samples were ordered to be taken from the winner Need A Margarita.

### **RACE 5 LUXBET CLASS 1 F&M HCP —1400 METRES**

**Speedonova** – Hampered at the start. Held up for a clear run, rounding the home turn.

**Farewell Angelina** – Jumped awkwardly. Shifted in over the concluding stages.

**Gee Gee Rich Ruby** – Shifted out at the start.

Routine samples were ordered to be taken from Shutterfly, the 2<sup>nd</sup> place getter in the event.

### **RACE 6 BOOK YOUR CHRISTMAS FUNCTION MDN/CL1 — 2100 METRES**

**Akbar Jay** - Jockey Brendon McCoull fined \$100 under AR 137A (5)(a)(ii) for using his whip on eight occasions prior to the 100 metres and in excess of 16 overall. Stewards took into account Jockey McCoull's relatively good record, guilty plea and the weather conditions of tonight's meeting.

**Berbent** – Got its head up and raced ungenerously for some distance.

**Hot Chisel** – Jumped awkwardly. Inconvenienced at the 800 metres.

#### **General:**

Stewards inquired into the reason for Hot Chisel (J Benbow) being inconvenienced near the 800 metres. Evidence established that near the 800 metres Chief Navigator (T Baker) which was racing in advance and to the outside of Hot Chisel had been racing ungenerously and Kingsclere (J Maskiell) when going forward and crossing at that stage of the race had shifted in marginally. Whilst accepting that Chief

Navigator had contributed to the incident, Jockey J Maskiell (Kingsclere) was advised to ensure that allows sufficient room to other runners when crossing.

### **RACE 7 — 1600 METRES**

**Gwemrae** – Slow into stride. Jockey C Newitt reported that the mare had suffered respiratory distress and consequently eased the mare down. A post-race veterinary examination revealed that the mare had possibly suffered a soft palate displacement. On Friday 13 October 2017 Trainer Barry Campbell advised Stewards that Gwemrae had recovered reasonably well and he would continue to monitor the mare's trackwork and advise the Stewards accordingly.

### **RACE 8 — 1400 METRES**

**Toorak Affair** – Slow into stride.

**Taramaya** – Jockey Sigrid Carr was fined the sum of \$200 under AR 137A(5)(a)(ii) in that she used her whip on nine occasions prior to the 100 metres. In determining penalty, Stewards took into account the Miss Carr's record, her guilty plea and weather conditions.
