Stewards spoke to trainer Michael Stringer in relation to the racing manners of Imagine Dragon in the home straight in that it marred the running of Enfield Lynx, after viewing the official patrol films, acting on their own observations and taking evidence from Mr Stringer Stewards were satisfied that Imagine Dragon had marred the running of Enfield Lynx by making muzzle contact to the head of the greyhound which was to it's inside. Acting under the provisions of GAR 69(2) (a) Imagine Dragon has been stood down from racing for a period of 28 days at Hobart only and until the completion of a satisfactory trial.
