RACE 1 – CURTAINS & BLINDS GRADE 6 (1) 515M

Wynburn Mustang was slow out. Soon after the start Buckle Up Demi and Last Mint bumped. Approaching the first turn Last Mint and Buckle Up Gina bumped, checking Buckle Up Gina which bumped with Posh Vera, at the same time Wynburn Mustang checked off the heels of Buckle Up Dino. On the first turn Buckle Up Demi and Buckle Up Dino bumped. On the second turn Wynburn Mustang checked off the heels of Buckle Up Demi. Entering the back straight Buckle Up Demi checked off the heels of Wynburn Mustang, checking Buckle Up Dino. Approaching the third turn Buckle Up Dino and Buckle Up Gina bumped. Entering the home straight Buckle Up Demi checked off the heels of Last Mint. In the home straight Buckle Up Gina galloped on the heels of Last Mint, checking Buckle Up Gina. Buckle Up Gina underwent a post-race veterinary examination which revealed the greyhound to have soreness to the left and right tensor fascia muscles. Buckle Up Gina has been stood down from racing for a period of 5 days.

RACE 2 – SIMONS CARPET ONE GRADE 6 (2) 515M

Soon after the start Dolly Does It crossed towards the rail at the same time Fasika crossed wide, checking My Bro Zorro, Buckle Up Vomo, Buckle Up Freda and Dolly Does It. In the front straight Buckle Up Vomo and Buckle Up Freda bumped on several occasions, checking Buckle Up Freda. Approaching the first turn My Bro Zorro, Buckle Up Vomo and Dolly Does It bumped, checking Buckle Up Vomo and Buckle Up Freda. Buckle Up Vomo underwent a post-race veterinary examination which revealed the greyhound to have superficial spike wound to the left hind foot and soreness to the left quadricep. Buckle Up Vomo has been stood down from racing for a period of 7 days.

RACE 3 – KINGSLEY JARMAN FENCING FFA 278M

Soon after the start Howzat Patsy and Rock On Rolla bumped, checking Rock On Rolla. Approaching the first turn Kettle's Cobber checked off the heels of Cashmeera, checking Howzat Patsy and Rock On Rolla. Entering the home straight Gold Drift checked off the heels of Kettle's Cobber. In the home straight Zinet's Girl and Rock On Rolla bumped, checking Zinet's Girl. A post-race swab sample was taken from Cashmeera winner of the event.

RACE 4 – GREAT NORTHERN SUPER CRISP GRADE 6 (3) 515M

Crackenback was slow out. Soon after the start Apocryphal, Buckle Up Bega, Eketahuna, Imagine Dragon and Wynburn Boxer bumped, checking Imagine Dragon and Eketahuna. In the front straight Eketahuna and Buckle Up Bega bumped on several occasions, checking Eketahuna. Approaching the first turn Buckle Up Bega checked off the heels of Crackenback, checking Imagine Dragon. On the first turn Wynburn Boxer and Buckle Up Glad bumped. On the second turn Imagine Dragon contacted the rail and then bumped with Buckle Up Bega. Approaching the third turn Eketahuna checked off the heels of Apocryphal as a result Imagine Dragon checked off the heels of Eketahuna, checking Buckle Up Bega. Buckle Up Bega underwent a post-race veterinary examination and no apparent injury could be detected. Imagine Dragon underwent a post-race veterinary examination and no apparent injury could be detected. A post-swab race sample was taken from Wynburn Boxer winner of the event.

RACE 5 – LUXBET CLUB XTRA GRADE 5 (1) 515M

Dyna Kungpow was slow out. Soon after the start I'm Mad and Metanoia Franko bumped. Approaching the first turn Call Me Charlie, Proven Eddie, Metanoia Franko, I'm Mad and Zizou De Kahn bumped as a result I'm Mad galloped on the heels of Proven Eddie, checking Proven Eddie and Metanoia Franko and severely checking I'm Mad which fell. On the home turn Metanoia Franko and Zizou De Kahn bumped. Aware tired over the concluding stages. I'm Mad underwent a post-race veterinary examination and no apparent injury could be detected. Aware underwent a post-race veterinary examination and no apparent injury could be detected.

RACE 6 – LGRC GOLD COLLAR HEATS 6TH NOVEMBER MIXED 2/3 515M

Smooth Jinx was slow out. Approaching the first turn Fink Racer crossed toward the rail checking Lucky Linc and Woosha, as a result Black Chevelle, Take Guard and Maharani were checked. On the second turn Smooth Jinx and Black Chevelle bumped checking Black Chevelle. Approaching the third turn Smooth Jinx crossed toward the rail checking Take Guard and Smooth Jinx as result Lucky Linc checked off the heels of Take Guard. On the third turn Lucky Linc checked off the heels of Smooth Jinx. In the home straight Santa Claws and Fink Racer bumped.

Santa Claws underwent a post-race veterinary examination which revealed the greyhound to have superficial grazes to both hind legs and right fore wrist. Santa Claws has been stood down from racing for a period of 7 days. Stewards spoke to trainer Mr Phillip Cassidy in relation to the race manner of Santa Claus in the home straight, acting on their own observations viewing the official replays and taking evidence from Mr Cassidy. Stewards were of the opinion that Santa Claws had turned it head outwards toward Fink Racer and shifted up the track hampering the running of Fink Racer and in doing so failed to pursue the lure of due commitment throughout the event by reason of injury pursuant to GAR 69B(1)(a), Santa Claws has been stood down from racing until the completion of a satisfactory trial.

RACE 7 – LUXBET RACING CENTRE GRADE 4 515M

The start of this race was delay by approximately 5 minutes due to the starting boxes failing to open on the first attempt. All runner were examined by the veterinary surgeon and passed fit to take place in the event. Pure Zest was slow out. In the front straight Keep Ya Looks crossed toward the rail, checking Demon Lad and then King Pedro crossed wide, checking Demon Lad and Pure Zest. In the back straight Keep Ya Looks commenced to lose ground. On the third turn Pure Zest checked off the heels of Keep Ya Looks. On the home turn King Pedro and Deni's Denial bumped. Keep Ya Looks underwent a post-race veterinary examination which revealed the greyhound to have abrasions to the right hock. Keep Ya Looks has been stood down from racing for a period of 5 days. A post-race swab sample was taken from Lobster Falls winner of the event.

RACE 8 – WINNING EDGE KIBBLE GRADE 5 (2) 515M

Vrontios, Cooper's Shadow, Pingles and Cheeky Ella were slow out. Approaching the first turn Hoity Toity checked off the heels of It's A Threat, checking Cooper's Shadow and Pingles. On the second turn Hoity Toity and Trumpence bumped. On the home turn Vrontios and Cooper's Shadow bumped. In the home straight Hoity Toity galloped on the heels of Apache Dream.

RUN ON: 3 1 5 2 4 6 8 9 MARGINS: 2 ¼ x HD TIME: 29.98

RACE 9 – LUXBET.COM GRADUATION/TRIAL QUALIFYING SERIES FINAL MIXED 4/5 278M

Nightmare Miss was slow out. Soon after the start Coal Tattoo crossed wide, shortly after Furious Trump, Nightmare Miss, Metro's Girl and Prancing Black bumped, checking Nightmare Miss and Prancing Black, at the same time Golden Nugget and Kath Emery bumped. In the back straight Suva and Metro's Girl bumped. Approaching the first turn Furious Trump checked off the heels of Metro's Girl checking Prancing Black. On the first turn Golden Nugget and Metro's Girl bumped. On the home turn Golden Nugget and Metro's Girl bumped. In the home straight Suva and Coal Tattoo bumped on several occasions. Coal Tattoo underwent a post-race veterinary examination and no apparent injury could be detected. Stewards spoke to trainer Mr Anthony Bullock in relation to the race matter of Coal Tattoo, shortly after the start and then approaching the finish, acting on their own observation viewing the official replay and taking evidence from Mr Bullock. Stewards were of the opinion that shortly after the start Coal Tattoo had turned its head outwards and then crossed wide on the track, and then also eased approaching the winning post and in doing so failed to pursue the lure with due commitment throughout the event pursuant to GAR 69A(1). Acting under the provisions of GAR 69A(2)(b) as this was this greyhounds second offence. Coal Tattoo has been stood down from racing for a period of 3 months, at all tracks and until a completion of a satisfactory trial. A post-race swab sample was taken from Suva winner of the event.

RACE 10 – FUND US ON FACEBOOK GRADE 5 (3) 515M

Frosty's Capable, Kalaway Cobs and Cawbourne Drive were slow out. Soon after the start Stylish April and Wynburn Geri bumped. On the first turn Hello Freckles checked off the heels of Stylish April. On the second turn Hello Freckles checked off the heels of Wynburn Geri. In the back straight Hello Freckles and Cawbourne Drive bumped. Entering the home straight Cawbourne Drive and Fancy Moss bumped. Fancy Moss raced wide in the home straight. Cawbourne Drive raced wide for the majority of the event.

General:

All Year Round completed a steward's satisfactory trial this greyhound was stood down from racing at the Launceston Greyhound Racing Club on the 10th July 2017 for marring (second offence) Pursuant to GAR 69(1). Weighing 32.6kg and beginning from box 3 All Year Round

completed the 278m trial distance in a time of 16.19. All Year Round has been cleared to race at all tracks.

Races 7,8,9 and 10 were all hand started due to a fault with the starting mechanism.
