Santa Claws completed a stewards satisfactory trial as the greyhound was stood down from racing at the Launceston Greyhound Racing Club on the 30<sup>th</sup> October 2017 for failing to pursue the lure by reason of injury, pursuant to GAR 69b(1)(a). Beginning from box 3 and weighing 33.9kg, Santa Claws completed the 452 metre trial distance in a time of 25.92. Santa Claws has been cleared to race at all tracks except Launceston.
