Approaching the winning post Kamikaze Turtle and King Pedro bumped, checking Kamikaze Turtle. Kamikaze Turtle underwent a post-race veterinary examination which revealed the greyhound to have pain to the inside thigh of both rear legs. Kamikaze Turtle has been stood down from racing for a period of 7 days. King Pedro underwent a post-race veterinary examination which revealed the greyhound to have a spike wound on the left front leg. King Pedro has been stood down from racing for a period of 2 days. Gold Ticket underwent a post-race veterinary examination and no apparent injury could be detected. Iona Fire underwent a post-race veterinary examination and no apparent injury could be detected. **General:**

Takunda completed a Stewards satisfactory trial as it had not competed in an event for a period of in excess of 6 months pursuant to LR 31.3. Weighing 36.5kg and beginning from box 3, Takunda completed the 452M trial distance in a time of 25.89. Takunda has been cleared to race at all tracks.

Trainer Mr R Hall was reprimanded pursuant to GAR 33(4) in that he presented his greyhounds to compete in today's events without the registration papers for his greyhounds.

Trainer Mr S Rowlands pleaded guilty to a charge pursuant to GAR 86(o) for misconduct in that he swore at Steward Ms A Norgrove when directed to return back to the Stewards room. In arriving at penalty Stewards took into account, Mr Rowlands record under this rule and the fact that Stewards do not condone this type of behaviour. Mr Rowlands was fined the sum of \$500 with \$250 being suspended for a period of 12 months on the condition that he does not breach this rule again throughout that time. Mr Rowlands was advised of his rights of appeal.
