Shima Sun underwent a post-race veterinary examination which revealed the greyhound to have soreness to the left fore leg and shoulder. Shima Sun has been stood from racing for a period of 8 days. Stewards spoke to trainer Mrs Margaret Rossendell in relation to the race manner of Shima Sun approaching the finish. Acting on their own observations viewing the official replays and taking evidence from Mrs Rossendell, stewards were of the opinion that Shima Sun had turned its head outward towards Bobby Bound making head and muzzle contact with that greyhound, and hampering Bobby Bound out onto Arugula, and in doing so marred the running of Bobby Bound pursuant to GAR 69(1), acting under the provisions of GAR 69(2)(a) Shima Sun has been stood down from racing for a period of 28 days at Launceston and until the completion of a satisfactory trial. A post-race swab sample was taken from Le Baz winner of the event.
