RACE 1 – GREYHOUND ADOPTION PROGRAM – GRADE 6(1) – 452M

Roll Call and Minto were slow out. Soon after the start, Roll Call and Minto bumped. At the same time Tyler Lee and Buckle Up Rose bumped. Approaching the first turn, Dinga Bell, King Kurt, Jetta Jam and Roll Call bumped, checking Dinga Bell, King Kurt and Roll Call and severely checking Jetta Jam which fell, checking Buckle Up Rose, Minto, Matter Wit' Chew and Tyler Lee. On the first turn, Roll Call, Buckle up Rose and King Kurt bumped, checking Buckle Up Rose. On the home turn, Tyler Lee checked off the heels of King Kurt. Jetta Jam underwent a post-race veterinary examination and no apparent injury could be detected. King Kurt underwent a post-race veterinary examination which revealed the greyhound to have spike wounds to the left hind paw, however no stand down period was applied. Minto underwent a post-race veterinary examination which revealed the greyhound to have spike wounds to the right hind paw, however no stand down period was applied.

RACE 2 – THE ADVOCATE – GRADE 6(2) – 452M

Soon after the start, Rusty The Jett and Apocryphal bumped, checking Apocrypha. Shortly after, Buckle Up Clint, Soda Belle, Kiandra and Doran's Flame bumped, checking Soda Belle, Buckle Up Clint and Kiandra. In the back straight, Ginger Mic and Medium Rare bumped. At the same time, Rust The Jett and Doran's Flame bumped. Shortly after, Soda Belle, Buckle Up Clint and Kiandra bumped, severely checking Buckle Up Clint and Kiandra, which fell. Kiandra underwent a post-race veterinary examination which revealed the greyhound to have bruising to the back left paw. Kiandra has been stood down from racing for a period of 3 days. Buckle Up Clint underwent a post-race veterinary examination and no apparent injury could be detected.

RACE 3 – GREYHOUNDS MAKE GREAT PETS – GRADE 6(3) – 452M

Bobby The Jett and Fiery Woman were slow out. Soon after the start, Falcie's Dasher, Buckle up Bega, Fiery Woman and Bobby The Jett bumped, checking Buckle Up Bega Fiery Woman and Bobby The Jett. Approaching the first turn, Chewing Nalin, Rookie and Magic Lizzie bumped, checking all three greyhounds and as a result, Falcie's Dasher was checked. On the home turn, entering the home straight and in the home straight Magic Lizzie and Chewing Nalin bumped on several occasions. Chewing Nalin, Rookie, Falcie's Dasher and Magic Lizzie raced wide in the home straight. Falcie's Dasher underwent a post-race veterinary examination which revealed the greyhound to have spike wounds to the right fore leg, however no stand down period was applied. Magic Lizzie underwent a post-race veterinary examination which revealed the greyhound to have a minor tear to the left groin muscle. Magic Lizzie has been stood down from racing for a period of 7 days. Stewards spoke to trainer Mr Barry Smith in relation to the race manner of Magic Lizzie rounding the home turn and entering the home straight. Acting on their own observations, viewing the official replays and taking evidence from Mr Smith, Stewards were of the opinion that Magic Lizzie had turned its head outwards rounding the home turn, towards Chewing Nalin and crossed wide and bumped with that greyhound on a number of occasions and in doing so had failed to pursue the lure with due commitment throughout the event, by reason of injury, pursuant to GAR 69B(1)(a). Magic Lizzie has been stood down from racing until the completion of a satisfactory trial.

RACE 4 – NORTH WEST ANIMAL HOSPITALEMI FINAL – DEVONPORT SE 452M

Wynburn Shakes was slow out. Approaching the first turn, Buckle Up Freda checked off the heels of She's A Fernando. On the first turn, Jacks High crossed wide, checking Buster Emery. Approaching the home turn, That's Pops Boy checked off the heels of Buckle Up Gina. Buster Emery underwent a post-race veterinary examination and no apparent injury could be detected. Jacks High underwent a post-race veterinary examination which revealed the greyhound to have a spike wound to the right fore leg however no stand down period was applied. Stewards spoke to trainer Mr Butch Deverell in relation to the race manner of Jacks High rounding the first turn. Acting on their own observations, viewing the official replays and taking evidence from Mr Deverell, Stewards

were of the opinion that rounding the first turn, Jacks High eased, turned its head outwards, crossed wide hampering the running of Buster Emery and in doing so failed to pursue the lure with due commitment throughout the event pursuant to GAR 69A(1) – Acting under the provisions of GAR 69 A(2)(a) Jacks High has been stood down from racing for a period of 28 days at Devonport and until the completion of a satisfactory trial.

RACE 5 – NORTH WEST ANIMAL HOSPITAL SEMI FINAL DEVONPORTSE 452M

Wynburn Geri, Bluegrass Moss and Apollo Blue were slow out. Soon after the start, Bluegrass Moss and Apollo Blue bumped. In the back straight, Top Thunder, One Eyed Magpie and Buckle Up Vomo bumped, checking One Eyed Magpie. Shortly after, Top Thunder checked off the heels of Buckle Up Vomo. On the first turn, Buckle Up Vomo checked off the heels of Dolly Does It. Approaching the Home turn, Top Thunder checked off the heels of Wynburn Geri, Checking One Eyed Magpie. In the home straight, One Eyed Magpie and Top Thunder bumped. A post-race swab sample was taken from Dolly Does It, the winner of the event.

Crackenback and Above Time were slow out. Soon after the start, Crackenback stumbled. In the back straight, Wynburn Mustang checked off the heels of Fernando Bolt. Approaching the first turn, Wynburn Mustang and Key Patrol bumped, checking Key Patrol. On the first turn, Crackenback and Wynburn Mustang bumped, checking Wynburn Mustang. On the home turn, Fernando Bolt and Buckle Up Maria bumped. In the home straight, Above Time crossed toward the rail, checking Buckle Up Dino. Approaching the finish Koko and Buckle Up Maria bumped.

RACE 7 – NORTH WEST ANIMAL HOSPITAL SEMI FINAL DEVONPORTSE 452M

Wynburn Lucifer, Times A Bonus and Fernando Magic were slow out. On the first turn, Classic Keybow galloped on the heels of Buckle Up Ellie, severely checking Buckle Up Ellie and checking Classic Keybow. At the same time, Major Mint and Reiki Master bumped. As a result, Fernando Gold checked off the heels of Reiki Master. Shortly after Times A Bonus checked off the heels of Buckle Up Ellie. Fernando Magic eased in the home straight. Buckle Up Ellie underwent a post-race veterinary examination and no apparent injury was detected. Fernando Magic underwent a post-race veterinary examination which revealed the greyhound to have bruising to the left calf. Fernando Magic has been stood down from racing for a period of 4 days. Stewards spoke to trainer Mr David Crosswell in relation to the racing manners of Fernando Magic in the home straight. Acting on their own observations, viewing the official replays and taking evidence from Mr Crosswell Stewards were of the opinion that Fernando Magic had turned its head inwards and outwards and had eased on a at least two occasions and in doing so failed to pursue the lure with due commitment throughout the event pursuant to GAR 69A(1). Acting under the provisions of GAR 69A(2)(a) Fernando Magic has been stood down from racing for a period of 28 days at Devonport and until the completion of a satisfactory trial.

On the first turn, Beau Wonder checked off the heels of Silent Boloney, checking Explosive Fox. Approaching the home turn, Bleached Apple and Explosive Fox bumped. In the home straight, Explosive Fox, Gold Lenny and Droopy's Ella bumped, checking Gold Lenny.

General:

He's A Boomer completed a Stewards satisfactory trial as this greyhound was stood down from racing at the NWGRC on the 14th of November 2017 for hypoxia, pursuant to GAR 74(1). Weighing 32.4kg and beginning from box 5, He's A Boomer completed the 452M trial distance in a time of 25.63. He's A Boomer subsequently underwent a post-race veterinary examination which revealed the greyhound to have post-race induced ataxia. He's A Boomer has been stood down from racing for a period of 30 days. Subsequently He's A Boomer has not been cleared to race.

What's In Store completed a Stewards Satisfactory trial as this greyhound had not raced for in excess of 6 months pursuant to LR 31.3. Weighing 28.6kg and beginning from box 3 What's In Store completed the 452M trial distance in a time of 26.19. What's In Store has been cleared to race at all tracks.
