RACE 1 – RACENAME

Nightmare Miss was slow out and tailed the field throughout the event. On the first turn Furious Trump and Majestic Girl bumped, checking Majestic Girl. Nightmare Miss underwent a post-race veterinary examination and no apparent injury could be detected. Stewards spoke to trainer Mr S Chambers in relation to the performance of Nightmare Miss. Acting on their own observations viewing the official replays and taking evidence from Mr Chambers, Stewards deemed the performance to be unsatisfactory pursuant to GAR 71 after the greyhound tailed the field throughout the event and was uncompetitive. Nightmare Miss has been stood down until the completion of a satisfactory trial.

Weona Vee and Rich Marlow were slow out. Approaching the first turn Weona Vee checked off the heels of Lahinch. Shortly after Lahinch checked off the heels of Storm Water.

RACE 3 – RACENAME

Whoop Bang, Dominator Flyer and Enfield Pete were slow out. In the back straight Dominator Flyer and Enfield Pete bumped. Approaching the first turn Dominator Flyer checked off the heels of Red Power, checking Enfield Pete. On the first turn Whoop Bang checked off the heels of Red Power, checking Enfield Pete. Entering the home straight Enfield Pete crossed wide hampering Whoop Bang. In the home straight Enfield Pete and Whoop Bang bumped, checking Whoop Bang. Enfield Pete underwent a post-race veterinary examination and no apparent injury could be detected. Stewards spoke to trainer Mr P Higgins in relation to the race manner of Enfield Pete entering the home straight. Acting on their own observations and viewing the official replays and taking evidence from Mr Higgins Stewards were of the opinion that Enfield Pete had turned its head outwards entering the home straight and then crossed wide hampering the running of Whoop Bang and in doing so failed to pursue the lure with due commitment throughout the event pursuant to GAR 69A(1) acting under the provisions of GAR 69A(2)(b) as this was this greyhounds second offence. Enfield Pete has been stood down from racing for a period of 3 months at all tracks and until the competition of a satisfactory trial.
